



#### **Recently, CSBA has:**

- Successfully advocated for state assistance with employer pension contributions
- Co-sponsored legislation addressing the teacher shortage, improving access to Medi-Cal for schools, and securing and funding relief for districts and counties affected by wildfires and other disasters.
- Stridently advocated in favor of legislation supporting increased Local Control Funding Formula and special education funding, addressing student health and improving academic outcomes, while lobbying against legislation that would subvert local governing authority.

- Issued timely Legislative Updates on facilities funding, pupil assessments, school start times, the state budget and other key issues.
- Analyzed hundreds of bills and resolutions, actively lobbying for the most critical legislative proposals.
- Advocated at the federal level on issues relating to the Individuals with Disabilities Education Act, Every Student Succeeds Act, Secure Rural Schools and Community Self-Determination Act, Carl D. Perkins Vocational Education and Technical Education Act, technology for rural communities and other issues.

## **Spotlight:** Legislative Action Day

Every March, on Legislative Action Day, school governance leaders from across California descend on the state Capitol to meet with their Assembly and Senate representatives and make their voices heard on critical education issues affecting their students, schools and communities.

In recent years, governance leaders have lobbied about:

- ▶ Full and Fair Funding<sup>SM</sup>
- the state budget
- LCFF

- the impact of pension costs
- special education
- school facilities funding
- transportation funding

To ensure participants are well-prepared, CSBA schedules the meetings with legislators and provides materials in advance, including a pre-event webinar and day-of issue briefings. All you have to do as a governance leader is arrive in Sacramento ready to communicate the needs of your local education community.

# **Legal Advocacy**

#### Your trusted source

for legal advocacy on behalf of public education interests.

#### **Recently, the Education Legal Alliance:**

Filed multiple successful lawsuits challenging the manipulation of the Proposition 98 minimum guarantee, including CSBA v. Cohen I (challenging the State's failure to recalculate the minimum guarantee after counting childcare spending); CSBA v. Cohen II (challenging the State's manipulation of Cost Allocation Schedule); and CSBA v. Bosler (challenging the State's unconstitutional attempt to schedule repayment of Prop. 98 underpayments over time), resulting in the State restoring hundreds of millions of dollars in additional funding.

- Filed amicus briefs and amicus support letters on issues including charter schools, special education, California Public Records Act, Deferred Action for Childhood Arrivals and more.
- Had its amicus brief cited by the Court in ruling in the school district's favor that a developer could not avoid paying developer fees levied by the school district on a new residential development project by intending to only house adult seasonal workers.
- Filed an amicus brief before the California Supreme Court in a case concerning recovery of costs for extraction of information under the California Public Records Act, explaining the unique and substantial financial burden facing school districts and county offices of education under the CPRA.

# Hundreds of Millions of Dollars Saved for School Districts.

In December of 2018, CSBA and its ELA filed a lawsuit against the State of California in *CSBA v. Bosler*, because the State's certifications indicated it intended to schedule repayment of previous Proposition 98 underpayments over time, instead

of paying it off as constitutionally required. CSBA demanded immediate repayment of \$686 million owed to school districts. As a result of the ELA's challenge, the Governor included repayment of the full \$686 million to our schools (in excess of \$110 per student) in the Governor's 2019-20 and 2020-21 budgets.

"As California continues to lag in funding its students, schools and future, the ELA challenged a misguided change to Proposition 98 that could have lowered future school funding by as much as \$784 million. The ELA is a true champion in the fight for Full and Fair Funding<sup>™</sup> and will continue to guard against attempts to weaken an already-fragile financial situation for California's K-12 education system."

As part of the Board of Directors Strategic Initiatives, CSBA's PACER program was designed to expand CSBA's political and legislative footprint across the state.

CSBA is building a team of Public Affairs and Community Engagement Representatives (PACERs) that will work to establish two-way communication between CSBA and its membership, connecting districts to CSBA services and training and broadening member participation in CSBA initiatives.

PACER priorities and job functions under the direction of CSBA's Political Director:

Serve as liaisons with CSBA Regional Directors, Directors-at-Large, Delegates and school/county board members as an informational resource and thought partner on specific CSBA initiatives and education issues.

- Work to increase the political presence of CSBA and its membership.
- Facilitate stronger local relationships between governing board members and the Legislature to advance CSBA legislative, political and ballot priorities.
- Equip CSBA members with relevant and timely information on education legislation, regulations and trends.
- Assist CSBA Political Action Committee (PAC) fundraising by facilitating the establishment of regional event committees and coordinating member fundraising efforts.
