Several plaintiffs' law firms are now monitoring the use of on-line images on behalf of various national and international artists, photographers and businesses, and striking quickly when they track down copyrighted images that have been used without a license to do so. Additionally, there continue to be copyright and trademark claims from large businesses and universities relative to use of logos and names. This session will address new plaintiff strategies, review some recent case studies regarding demands that have been made of California school districts, and will discuss strategies for dealing with such demands when they are received. The presenter will also address best practices that can be shared with school district clients (and that provide some good reminders for law firms as well!). School districts receive volumes of public records requests and complaints which implicate laws, policies and procedures outside the realm of just one department or area of law. 

But even in the wake of Anderson Union High School Dist. v. Shasta Secondary Home School, numerous charter schools continue to operate outside the boundaries of their authorizing LEA. During this session, attendees will explore the post-Anderson state of play for out-of-district charter schools and discuss recent legislation in this area. 2:20 – 3:35 pm (1.25 Elimination of Bias MCLE)	Implicit Bias in the Legal Profession: Awareness & Interruption – This presentation defines and explores Implicit Biases that people carry within them, and how that affects the practice of law. Discussion includes attorneys' external relationships with clients, judges, witnesses, and opposing counsel, as well as internal relationships in a law firm or as in-house counsel. What is the impact on the legal profession of our unconscious assumptions and associations about race, gender, sexuality, religion, age, and other identities? Authorities relied upon in the presentation include controlled studies and scholarly writing by the American Bar Association and professors and other experts from the fields of law, sociology, and education. Focus is added to address how attorneys representing public education entities and stakeholders are especially benefitted and burdened by our client base in dealing with implicit bias. Special emphasis is on interrupting bias, so as better to ensure non-discriminatory and fair treatment of both external contacts and an attorney's own peers and colleagues.
