***Benefits of Membership***

**Easy and Economical MCLE Compliance:** CCSA makes MCLE compliance easy and economical through programs that are directly relevant to school-law attorneys at every level of experience. Through four full-day trainings per year that alternate between northern and southern California, CCSA offers all the required hours you will need for MCLE compliance - including legal ethics, competence issues, and recognition and elimination of bias in the legal profession and society. Our September and May workshops alternate between southern and northern California. We hold our annual 2-day annual conference each December, in conjunction with CSBA's AEC — which will be held in Anaheim this year.

**Access to Potential Clients:** Membership in CCSA provides great opportunities to share your knowledge and expertise with your colleagues and gain access to clients and potential clients at CCSA workshops. In addition to our spring, fall and annual conferences, the CCSA Board selects presenters for CSBA's Annual Education Conference and Trade Show ("CSBA's AEC") pre-conference Legal Symposium for Experienced Board Members. The Board selects presenters for the Legal Symposium based on a variety of factors including prior attendance and involvement with CCSA conferences, and makes every attempt to ensure presentation opportunities are shared equitably among our active membership. I am pleased to inform you that CCSA will deliver the same high quality of programming in 2020-21 without any increase to membership dues for the membership cycle.

Given the many benefits of CCSA membership, we are hopeful that school-law firms will expand their participation. Some of the many ways that CCSA enhances the professional life of its members include:


