Re: Call for Nominations to CSBA's Delegate Assembly

Each year, member boards elect representatives to the California School Boards Association's Delegate Assembly. The Delegate Assembly is a vital link in the Association's governance and sets the general policy direction. Working with member boards, the Board of Directors, and the Executive Committee, Delegates ensure the Association promotes the interests of California's school districts and county offices of education. Delegates with terms that end in 2026 are up for election. Ballots for the Delegate Assembly election will be sent to each member board within the region or subregion by February 1, 2026. Delegates elected in 2026 will serve a two-year term beginning April 1, 2026 and ending March 31, 2028. There are two required Delegate Assembly meetings each year; in 2026, the dates are May 16-17 and December 1-2. **NOTE:** This year your board will have the opportunity to participate in the election electronically via Simply Voting (you may view a demo HERE). Paper ballots will still be mailed by February 1, 2026 so boards may choose to participate via mail or electronically

The following DA Regional County seats are up for election in 2026:

- Region 2: Modoc, Siskiyou, Trinity, Shasta, Plumas, Lassen Jodee Reed (Plumas County & USD)
- Region 4: Glenn, Tehama, Butte, Colusa, Sutter, Yuba, Nevada, Placer, Sierra David Patterson (Placer COE)
- ➤ Region 6: Yolo, Sacramento, Alpine, El Dorado, Mono Shelton Yip (Yolo COE)
- ➤ **Region 8**: Amador, San Joaquin, Calaveras, Tuolumne, Stanislaus, Merced Steven Treat (Tuolumne COE)
- **Region 10**: Mariposa, Madera, Fresno, Kings Marcy Masumoto (Fresno COE)
- ➤ **Region 12**: Tulare and Kern Tony Rodriguez (Tulare COE)
- ➤ **Region 16**: Inyo and San Bernardino Laura Mancha (San Bernardino COE)
- ➤ **Region 18**: Riverside and Imperial Lucy Hendry (Imperial COE)

Nomination and biographical sketch forms for CSBA's Delegate Assembly are being accepted until **Wednesday**, **January 7**, **2026**. The nomination process is as follows:

Only CSBA member county boards of education may nominate a board member for the County Delegate seat in their region.

- Nominees must serve on a CSBA member county board of education from the region or subregion.
- ➤ Boards eligible to appoint must do so by January 7, 2026.
- Nominating boards must submit a separate Nomination Form for each person nominated and must ensure that the nominee has consented to being nominated.
- ➤ All nominees must submit a required biographical sketch form.
- Nominees may submit an optional one-page, one-sided résumé.
