State Board adopts LCFF rules after hearing from 160 school governance teams

Emergency regs, LCAP template may be refined before permanent adoption

After a seven-hour public hearing Jan. 16, the State Board of Education unanimously approved emergency Local Control Funding Formula regulations and a template for Local Control and Accountability Plans that maintain the balance between local flexibility and accountability sought by CSBA and other public school advocates. More than 160 school governance team members made the trip to Sacramento to comment. CSBA Executive Director & CEO Vernon M. Billy said it was clear that school board members helped convince the State Board to preserve local boards' much-needed flexibility. "Our voices were heard and we made a difference," Billy wrote in a letter of thanks to CSBA members. State Board also acts on CCSS-aligned instructional materials, other topics

In this 4½-minute video recapping "the quieter of the two days" of the State Board of Education's meeting last week, CSBA Senior Director of Policy and Programs Teri Burns opens with the "positive news" that board President Michael Kirst and members Carl Cohn and Patricia Rucker have been reappointed to new terms on the policymaking body. Burns also reports:

- Despite having Academic Progress Index scores of 799 or higher, 84 local educational agencies had to be identified for corrective action under federal No Child Left Behind requirements
- English Language Arts/English Language Development instructional materials aligned with the Common Core State Standards were approved for public review and comment prior to subsequent SBE action
- Regulations for the new California Assessment of Student Performance and Progress, which is replacing the Student



Testing and Reporting program, were approved for review and comment.

The State Board also approved the first Common Core-aligned mathematics materials.

Career Pathways grants competition opens

Letters of intent due Feb. 14; CDE plans workshops in Fresno, Sacramento and Downey

Applications are now being accepted for one-time competitive grants from California's \$250 million California Career Pathways Trust, with as much as \$15 million available for larger regional programs, State Superintendent of Public Instruction Tom Torlakson and Senate President Pro Tem Darrell Steinberg announced Tuesday. Steinberg championed the fund "to create innovative programs and partnerships linking rigorous academic standards to career pathways in high-need and high-growth sectors of the economy." School districts, county offices of education, charter schools, and community college districts can apply; letters of intent are requested by Feb. 14, with applications due March 28. The California Department of Education will host these regional workshops on the application process:

- Fresno County Office of Education: Feb. 5, 9-11 a.m.
- Health and Human Services Auditorium, Sacramento: Feb. 7, 1-3 p.m.
- Los Angeles County Office of Education, Downey: Feb. 12, 9-11 a.m.

Feb. 6 webinar ties reducing chronic absence to LCFFLeveraging Attendance for Equitable Outcomes: Tools for the Local
Control and Accountability Plan (LCAP) in California

California's new Local Control Funding Formula for K-12 education will require every school district to establish annual goals and specific actions to reduce chronic absence—defined, as anyone knows who has heard **Attendance Works** Director Hedy Chang at CSBA's Annual Education Conference or elsewhere, as missing 10 percent or more of school days. Now a 10 a.m.-11:15 a.m. webinar Feb. 6 will help:

- Determine whether chronic absence is a hidden problem in participants' schools or districts
- Identify which schools and subgroups of students require interventions to improve attendance
- Provide guidance on effective steps that can improve attendance
- Prepare goals and activities to meet the requirements of LCFF's Local Control and Accountability Plans
