## LCFF toolkit: 5 new video tutorials, LCAP template and regs

## Plans gearing up for Summer Food Service Program Funding available; mandatory CDE trainings begin soon

Do at least half of your students qualify for free or reduced-price school meals? Plan now to help them through the Summer Food Service Program. This federally funded program reimburses sponsors for administrative and operational costs of providing meals to children during the summer break—or whenever school is out of session for 15 continuous school days. California Department of Education training is required to participate, and CDE is offering both online webinars and in-person workshops to qualify. Options include daylong trainings in Sacramento Feb. 21, San Bernardino March 4, Glendale April 8, Long Beach April 10, and Oakland April 23; or twopart webinars—one Feb. 4-5, the other March 18-19—with each from 8:30 a.m. to 12:30 p.m. The CSBA policy brief "Providing Access to Nutritious Meals During Summer" has more information on the Summer Food Service Program, and our Web page on Student Physical Health and Wellness has more on the link between good nutrition and academic achievement, as well as on the role of school leadership in promoting student wellness. #### New guidance to support children in foster care Partial credit policy is tool for LCFF success

The Alliance for Children's Rights has released a comprehensive handbook to help schools recognize academic work completed by foster children who change schools midway through the school year.

California's Partial Credit Model Policy: Improving the Educational Outcomes of Foster Youth was produced as part of a collaborative overhaul of existing policy to ensure that foster students whose schooling is interrupted by frequent moves are able to receive credit for academic work. A work group organized by the Alliance—which included CSBA, the California Department of Education and a long list of other children's advocates—spent months developing the partial credit policy language that was adopted by the Child Welfare Council last fall. The handbook is of special interest to educators who must adopt effective services to better support children in foster care as part of their Local Control Accountability Plans under the Local Control Funding Formula.

#### Career Pathways grants competition opens Letters of intent due Feb. 14; CDE plans workshops in Fresno,

#### Sacramento and Downey

Applications are now being accepted for one-time competitive grants from California's \$250 million California Career Pathways Trust, with as much as \$15 million available for larger regional programs, State Superintendent of Public Instruction Tom Torlakson and Senate President Pro Tem Darrell Steinberg announced Tuesday. Steinberg championed the fund "to create innovative programs and partnerships linking rigorous academic standards to career pathways in high-need and high-growth sectors of the economy." School districts, county offices of education, charter schools, and community college districts can apply; letters of intent are requested by Feb. 14, with applications due March 28. The California Department of Education will host these regional workshops on the application process:

- Fresno County Office of Education: Feb. 5, 9-11 a.m.
- Health and Human Services Auditorium, Sacramento: Feb. 7, 1-3 p.m
- Los Angeles County Office of Education, Downey: Feb. 12, 9-11 a.m.
