## CSBA co-sponsored transportation bill advances SB 1137 would equalize reimbursements, provide COLA

With strong bipartisan support, the Senate Education Committee last week approved SB 1137, by Sen. Norma Torres, D-Pomona, that would equalize reimbursement rates for home-to-school transportation costs. The bill—which updates the state's legacy reimbursement amount—is co-sponsored by CSBA and the California School Employees Association, with support from the Small School Districts Association, the California Association of School Business Officials and a number of districts and counties from around the state. Currently, some school districts and county offices of education receive less than 10 percent of their approved costs, while others get more than 80 percent. SB 1137 would increase the reimbursement rates for districts receiving less than 50 cents on the dollar, and provide an annual cost-of-living adjustment. "Making sure children can get to and from school safely needs to be a top priority," said Sen. Torres in a statement. "Today we have children that have to walk home from school along busy roads and intersections. In some cases children have been injured." Estimates of how much specific entities could receive under the bill and an SB 1137 fact sheet are available on Sen. Torres' website. The bill next goes to the Senate appropriations committee for consideration.

# CSBA issues legal guidance on international student exchange placement organizations

Using placement organizations to enroll international students brings benefits and potential problems

With the help of international student exchange placement organizations, California school districts have recently been enrolling an increasing number of international students. While international students benefit from this experience, districts and their resident students benefit as well—international students offer new perspectives in classrooms and on the playground, and offer resident students a glimpse of what another part of the world is like. International students also must pay their full cost of enrollment. However, the laws and regulations over this area are limited, which allows for problems to arise. To assist districts in avoiding such problems, CSBA recently published legal guidance on this topic to address some of the most common questions about working with international student exchange placement organizations.

# AG urges districts to address truancy, chronic absenteeism in LCAPs

In an April 7 letter to district and county superintendents, Attorney General Kamala Harris urged districts and counties to address truancy and chronic absenteeism in their Local Control and Accountability Plans. Accompanying the letter was a sample LCAP that includes school attendance and chronic absenteeism rates as measures of the state priority of pupil engagement. The letter, sample LCAP and a set of frequently asked questions are posted on the Office of the Attorney General website. As noted in the FAQs, the AG's office does not have an official role in reviewing LCAPs: "However, the Attorney General is interested in supporting districts and counties in their efforts to successfully implement LCFF because she understands that there is a direct connection between public education and public safety, and that an important factor in improving educational outcomes is increasing student attendance." The attention to addressing truancy and chronic absenteeism follows the release of the attorney general's 2013 report, "California's Elementary School Truancy & Absenteeism Crisis: In School and On Track," and the AG's sponsorship of a package of five bills on these topics.
