SBE hears public comments on latest LCAP changes CSBA recommends 'moving ahead,' passing final regulations

The State Board of Education at its Thursday, Sept. 4 meeting heard testimony from CSBA, CASBO, ACSA, students, student advocacy organizations and other groups on the latest changes to the Local Control and Accountability Plan regulations. Many of the representative stakeholders who testified at the SBE's July meeting were in attendance, but their numbers were fewer, as were their concerns with the latest changes to the regulations, which include a clarified definition of the term "parent advisory committee" and a requirement that districts involve pupils in the "development of the LCAP." Some commenters pressed for further changes, including attaching to the LCAP a copy of the district or county proportionality calculation. However, speakers across the board commended the SBE for listening to their comments in July and for the work they've done to get the LCAP to where it is today—"within a hair's length," of being completed, said SBE Member Sue Burr after hearing comments from many who said they were ready to progress to the next stage. "Districts would rather have a template sooner than later," said CSBA Senior Director of Policy & Programs Teri Burns. "We are already in the process of preparing next year's LCAP. We would like to know what that document would look like. Moving forward would be a tremendous help." View the webcast of the meeting on the SBE's website. The latest changes are now in a second 15-day comment period. The SBE will either approve the final regulations at its next meeting, in November, if no further changes are made, or it will delay adoption until January 2015.

"We believe California's implementation of the Common Core standards and aligned assessments has the potential to dramatically improve college readiness and help close the preparation gap that exists for California students," wrote the leaders of the state's four

systems of higher education in an Aug. 29 letter to the State Board of Education. The SBE issued a news release on the following Wednesday commending this "unprecedented" endorsement of the CCSS by the California State University, University of California, California Community Colleges and Association of Independent California Colleges. "This endorsement reinforces other significant actions by higher education to align standards and assessments with Common Core ...," said Mike Kirst, president of the SBE. In their letter, the higher education leaders note that revisions were made to CSU and UC admission requirements to align with the CCSS, and that faculty are working in teams on the performance standards for the Smarter Balanced 11th grade assessment. The letter observes that "collaborative efforts" will help ensure that the tests measure standards that K-12 and higher education systems agree address appropriate expectations for preparing high school students to succeed. Brookings report examines superintendents' impact on student achievement NSBA issues comments

The impact of superintendents on student achievement is the subject of a new commentary by the National School Boards Association. The NSBA discussed a report by the Brown Center on Education Policy at the Brookings Institution. That report determined it is the school system—including students' socio-economic background and teachers—that has the most influence on student achievement, not the superintendent. For the NSBA, this finding underscored the importance of strong collaboration between school boards and superintendents. "What is left unsaid in the Brookings report is that such partnership is central toward effective collaboration with principals, teachers, and parents," Thomas J. Gentzel, NSBA executive director, said. In its own report, NSBA's Center for Public Education found that school boards with unclear or slow-to-form visions often hired superintendents with other goals. As a result, such school systems struggled to present unified goals and make progress towards them. Read NSBA's comments on the report.
