#### Help repeal cap on district reserve levels Adopt resolution calling for repeal of the reserve cap language

CSBA continues its efforts to repeal the cap on school district reserve levels that was enacted in June as part of SB 858, the education budget trailer bill. These new requirements are in Education Code Section 42127.01. To help support the repeal efforts, CSBA is asking school boards to:

- Adopt resolutions calling for the repeal of the reserve cap language, which takes effect if Proposition 2 is approved by voters:
- Talk with legislators and candidates for legislative office about the reserve cap and how it runs counter to sound fiscal practices, including the legitimate uses and needs for reserves; and
- · Send letters and emails to editors of local publications

CSBA has developed communication materials, including a sample resolution, talking points, Q&A and press release, for members to use when advocating for the repeal of the reserve cap. For additional information on this issue, please visit CSBA's dedicated Repeal Cap Web page.

#### CSBA opposes Proposition 46 No position taken on other measures

CSBA's Delegate Assembly voted in May to oppose Proposition 46 on the November ballot. The measure proposes increasing the award limit for medical malpractice lawsuits from the current limit of \$250,000 to an inflation-adjusted amount of \$1.1 million. According to separate analyses written by the state's Legislative Analyst's Office and by former Legislative Analyst William Hamm, the increase will likely result in higher health insurance costs for all consumers, including school employers. The school cost alone could reach \$200 million annually. CSBA did not take a position on any other measure. Many questions have been asked about Proposition 2, the state Rainy Day Fund, and its relation to budget trailer bill language capping school district reserves. The CSBA Board of Directors declined to take a position on



Proposition 2, opting instead to maintain focus on repealing the reserve cap through legislation.

## LAO releases 2014-15 Budget Spending Plan New report includes August and September legislative actions

The Legislative Analyst's Office, a non-partisan fiscal and policy adviser to the California legislature, has released the report, the 2014-15 Budget: California Spending Plan. The publication summarizes California's 2014-15 spending plan, including legislative and gubernatorial action through October 2014. This final published version reflects bills that were approved in August and September 2014. Figures, however, reflect estimated spending totals as of the June version of the budget act. **Read the full report** now. Visit **CSBA's website** for other 2014 legislative news.

## Legal Guidance on Grade Span Adjustment (Class Size) under LCFF

Guide for districts on securing and maintaining GSA funding

The Grade Span Adjustment under LCFF provides school districts with additional funding if school districts limit K-3 class sizes or agree to class size averages via the collective bargaining process. The additional funding amounts to approximately 10 percent of the LCFF base grant. To learn more about GSA conditions, procedures, and requirements visit CSBA's GSA Legal Guidance. ## CDE boosts awareness of mental health issues CSBA provides sample policy for boards

The California Department of Education is launching a pilot program to strengthen and increase awareness of mental health in school. The program plans to train 1,875 school staff members and others in awareness of mental health issues. Participants will learn how to identify and respond to students struggling with mental health concerns and how to get them help. (CSBA has a sample policy to help guide school boards on suicide prevention issues.) Trainees will then train other school professional across California. The five-year pilot program, funded by a federal grant from the Substance Abuse and Mental Health Services Administration, will take place at the Garden Grove Unified School District, Santa Rosa City Schools and the San Diego County Office of Education.
