LAO releases 2015-16 Budget: Prop 98 Education Analysis

Report agrees with proposed \$500 million for adult education, rejects CTE program

The Legislative Analyst's Office recommends the state Legislature improve some of Gov. Jerry Brown's Proposition 98 proposals and reject others. Gov. Brown's budget includes \$7.8 billion in Proposition 98 funding increases for schools and community colleges. The new LAO report, 2015-16 Budget: Proposition 98 Education Analysis, agrees with the proposal to provide \$500 million for adult education,

while recommending Gov. Brown incorporate some proposed workforce funding into the adult education program. The LAO report recommends rejecting the proposed Career Technical Education program and suggests that the proposed Technology/Internet Infrastructure program be rethought. There are also recommendations for the LCFF, county offices of education, and education mandates. For the mandates, the LAO supports paying off mandates with the \$1.1 billion in ADA funding as proposed by the Governor. Gov. Brown's proposed \$7.8 billion in funding includes "\$5 billion for programmatic increases and \$2.8 billion for retiring outstanding obligations." Read the LAO report.

Foster Youth Toolkit to help districts meet needs of foster youth

Toolkit covers foster youth education rights, includes enrollment tools

Published by the Alliance for Children's Rights, a new Foster Youth Education Toolkit aims to "assist school districts in meeting the promise of LCFF for our foster youth, ensuring they receive the full benefits of laws designed to protect them," according to a statement about the toolkit on the Alliance for Children's Rights website. The toolkit is divided into five sections that provide comprehensive information on the education rights of foster youth along with step-by-step procedures and tools to help districts engage in best practices for foster youth education. The tools provided can be used by any school district, but can also be adopted to fit local conditions. CSBA, CCSESA and other statewide organizations support the toolkit. Resources available to assist LEA staff

Report finds districts not doing enough to support foster youth

Districts must address the unique needs of foster youth

When the California Legislature adopted the LCFF, it was a requirement that school districts address the needs of foster youth. Unfortunately, in a new statewide **report**, major findings have shown a lack of district focus on addressing foster youth's unique needs. Some distressing findings in the report include: out of 64 school districts with more than 150 enrolled foster youth, only two districts identified baseline attendance rates for foster youth and only one out of those

same 64 districts identified a goal targeting foster youth expulsion rates. Support is necessary for the academic achievement of foster youth. These youth deal with a much different set of issues, such as trauma, moving from home to home and multiple school transfers. Because of this, they are less likely to graduate from high school than English Learners, students from low-income families, and students with a disability. CSBA Delegate Assembly elections ballots mailed Districts, COEs and candidates to be notified of results April 1

Ballots for CSBA's 2015 Delegate Assembly elections were mailed to school districts and county offices of education in early February. Completed ballots should be returned to CSBA's office at 3251 Beacon Blvd., West Sacramento, CA 95691, and must be postmarked by the U.S. Postal Service no later than Monday, March 16, to be considered valid. All districts, county offices of education and candidates will be notified of the results by April 1. Run-off elections will be conducted in the case of a tie. The **Delegate Assembly** meets twice each year. It sets CSBA's general policy direction and fulfills a critical governance role within the association. Delegates act as liaisons between CSBA and local board members in their regions, and they also meet with the other delegates and the CSBA director in their regions. Delegates serve two-year terms that begin April 1. All new and re-elected delegates are eligible to take part in the May 16-17 Delegate Assembly in Sacramento.
