LAO issues report on budget revision scenarios State revenue projections likely to increase

On Tuesday, the Legislative Analyst's Office released a report, The 2015-16 Budget: Possible May Revision Scenarios. The report is based on the significant potential that, come May, state revenue projections will significantly increase from the January 2015 estimates tied to the Governor's proposed 2015-16 budget. The report details what these increased revenues could mean for Proposition 98 funding and state reserve accounts and outlines five potential hypothetical scenarios that could emerge. Four of the five scenarios could create budget issues for 2015-16. Most notably, if the majority of the projected revenue increase in 2014-15 goes to Proposition 98 spending, it could create budget pressures on the non-Proposition 98 side of the state budget in 2015-16. Additionally, the LAO offers that the state could explore changes in Proposition 98 calculations, but if state revenue does rise significantly by May, schools still would receive significantly more funding than assumed in the Governor's January budget, even if the state were to adopt these changes. CSBA publishes fact sheet on Assembly Bill 420 Provides guidance on complying with the new discipline legislation

A new **fact sheet** published jointly by CSBA and Public Counsel offers school board members guidance for complying with Assembly Bill 420, which took effect at the beginning of 2015. AB 420 eliminates the authority of school districts to issue both in-school and out-of-school suspensions to students in kindergarten through third grade for disruption or willful defiance. The fact sheet provides background information on the use of suspension as a disciplinary practice, summarizes studies that show how suspensions and expulsions are harmful to students and explains that district compliance with AB 420 will help students by keeping them in learning environments for longer periods and providing them with needed supports. Los Angeles USD's Garfield High School and schools in Oakland USD are cited for their effective use of alternative approaches, such as Restorative Justice



and Positive Behavioral Interventions and Supports. The fact sheet addresses what AB 420 means for board members and provides action items, questions for board members to consider and additional discipline and suspension resources. Read the fact sheet.

New federal option simplifies school lunch, breakfast programs

Schools no longer required to collect applications for meals

A new federal option that simplifies the National School Lunch and Breakfast Programs administrative processes aims to help students go to school with hungry minds, not stomachs. The Community Eligibility Provision simplifies National School Lunch and School Breakfast Programs for districts that serve a high percentage of students from low-income families. Under CEP, schools offer breakfast and lunch at no charge to all students and will no longer have to collect school meal applications. According to a new CSBA fact sheet, a major benefit of the CEP is that it increases participation in school meal programs and reduces the stigma for children from low-income families. It frees up staff time for education priorities and frees up resources that can be invested in meal improvements. In addition, schools that adopt the CEP do not have to track meals served by eligibility categories. Instead, schools simply count the total number of meals served and receive reimbursements based on a formula. CEP is part of the Healthy, Hunger Free Kids Act of 2010, and administered by the U.S. Department of Agriculture. Read the Fact Sheet and learn how districts can adopt CEP.
