CSBA creates SBAC talking points for board members *Key messages to assist communications with parents, constituents*

As families this summer receive individual student score reports for California's new statewide assessments in English language arts and mathematics, they may have questions and need assistance understanding the results. To aid board members in their conversations with parents and community members about the Smarter Balanced scores, CSBA has developed some talking points. Briefly stated, the three key messages to convey are: 1) the tests are just one part of a much bigger K-12 remodeling effort that will require time and effort to carry out; 2) the SBAC results are different from the previous state test, and it is important to understand that 2015 results *cannot* be compared to previous years' results; and 3) the tests represent just one gauge on California's new dashboard approach to measuring student learning, with the 2015 scores establishing a new baseline. As a reminder, the California Department of Education recommends LEAs avoid releasing Smarter Balanced results until the CDE publicly releases statewide results in mid-to-late August.

Governance Brief recommends actions boards can take to improve school climate

Education reform efforts often fail because they are too big, happen too fast, are pursued in isolation, lack long-term commitment or are not clearly understood by stakeholders. But school boards have the power to overcome these and other barriers to improving school climate by focusing their governing work in five areas, according to a [new CSBA Governance Brief: "How boards change school climate."](#) Boards should: 1) Establish the current reality of school climate — measure and discuss; 2) set clear direction for school climate; 3) align school climate improvement with other key systems; 4) provide resources to support improving school climate; and 5) create partnerships. The brief discusses each area and provides examples of how boards, when establishing or revising policies related to school climate, can ensure clarity of expectations and consistent accountability. Although school climate is just one of eight state priority areas identified in the LCFF statute, "Improving school climate may be a highly effective overarching strategy for improving student achievement and district performance," [states the brief.](#)
