COVID-19: New resources for LEAs; survey collecting testing strategy information



The Centers for Disease Control and Prevention **released new guidance on Sept. 15 to aid local educational agencies in school reopening decisions.** Though the guidance comes well after the start of the school year for many LEAs, it provides suggested reopening criteria for states that have not set their own. California released updated reopening guidelines for the economy

and schools **on Aug. 28** that are more detailed than those from the CDC, so **no additional measures are necessary for LEAs.** The CDC document proposes three core indicators that should drive decision-making and, similar to California's new guidelines, **includes a color-coded system that determines lowest- to highest-risk areas depending on the core indicators.** [Read more on the CSBA blog »](#)

In other COVID-19 developments:

- In collaboration with the State Board of Education and the California Health and Human Services Agency, the California Department of Education is **collecting information on local COVID-19 testing strategies for schools via an [online survey](#).** Please **respond to this survey by Oct. 2, 2020.** The **information collected will be critical in helping inform officials' decisions moving forward in developing state testing strategies and supports.** The survey should take 10-15 minutes to complete, and only needs to be completed by one representative from each LEA or private school. - In the agreement on a [resolution](#) to extend government funding through Dec. 11, **Congressional and White House officials included an extension of the school lunch program waivers that have ensured millions of children remain fed during school closures caused by the pandemic.** Specifically, the resolution **extends the USDA's authority to issue child nutrition waivers through fiscal year 2021.** CSBA, as part of a larger nutrition coalition, has been [advocating for the USDA to extend these essential waivers](#) and increase funding to better ensure that school districts and county offices of education are equipped to provide the nutritious meals that children across the country need now more than ever. - The California Collaborative for Educational Excellence has published online [The Health & Safety Guidebook for California LEAs](#), which builds on industry guidance from the California Department of Public Health. Developed in collaboration with the California State Board of Education, **the resource supports the safe reopening of schools by providing rationale, tools and resources that LEAs can use or adapt** to support their community health context, facilities and school operations, safe school environments, and cohorts and schedules. - The Federal Communications Commission on Sept. 16 announced **a second E-Rate application window for funding year 2020, with applications being**

accepted until Oct. 16, 2020. With the funds, **schools will be able to purchase additional bandwidth to address digital learning demands** associated with instructional changes associated with the pandemic. [Learn more »](#)

Legislative update: Governor signs bills related to worker's compensation and funding



Gov. Gavin Newsom continues to sign and veto this year's crop of legislation, with a deadline of Sept. 30 just a week away. In the last week, **the Governor signed two key bills related to worker's compensation during the COVID-19 crisis and the 2020—21 education budget.** CSBA will continue to update members as additional legislation is signed or vetoed.

- **Senate Bill 1159 (Hill, D-San Mateo)** adds **COVID-19-related illness or death to the list of on-the-job injuries covered by worker's compensation until Jan. 1, 2024**, and reduces an employee's burden to prove that they contracted COVID-19 at work. The bill is effective immediately.
- **Budget trailer bill SB 820** makes further changes to the education budget and related requirements for LEAs. **The bill creates a pathway for LEAs to receive average daily attendance funding for growing enrollment during the state of emergency and provides additional time to spend and report learning loss mitigation funds.** SB 820 also **creates reporting requirements** for the new Learning Continuity and Attendance Plan template and clarifies distance learning requirements related to synchronous and asynchronous learning and recording. The bill is effective immediately.

CCBE virtual conference features inspiring sessions and informative speakers



The California County Boards of Education hosted its first virtual annual conference Sept. 11–12, offering an array of learning opportunities. Individual sessions included **strategies for managing alternative school programs; teaching and supporting students' social-emotional health during the COVID-19 crisis; and a focus on providing equity for all students.** Keynote

speakers covered the pressing digital divide and offered a legislative recap, and **CCBE President Janet Wohlgemuth and CSBA President Xilonin Cruz-Gonzalez lauded the critical work of county board trustees during these tumultuous times.** “Our current challenges exceed the capacity of local school districts to handle alone. School districts and the students they serve rely on county boards for information, guidance and support and to be the bridge between their local communities and the state.” Cruz-Gonzalez said. Public feedback sought for Comprehensive State Literacy Plan



The state’s **draft Comprehensive State Literacy Plan** is now open for its public comment and review period, with a **survey posted online** and comments also being accepted **via email**. The draft plan, which is a key part of the California Department of Education’s work to implement a federal literacy grant, **aligns and integrates state literacy initiatives, content standards and**

state guidance documents to support teachers of students through grade 12. The feedback period will close on Oct. 28. At its November meeting, the IQC will consider feedback for potential revisions to the draft plan. [Learn more and offer your feedback »](#)
