### COVID-19 update: Department of Education issues guidance on use of federal relief funds



The U.S. Department of Education released [Frequently Asked Questions about how states and school districts may use funding provided through the Elementary and Secondary School Emergency Relief \(ESSER\) Fund and the Governor's Emergency Education Relief \(GEER\) Fund to respond to the COVID-19 pandemic](#). The document includes a long list of allowable uses

relating to learning recovery initiatives, COVID-19 mitigation strategies, purchasing technology, providing mental health services and supports, summer learning initiatives, facilities repairs and more. #### In other COVID-19 developments:

- President Joe Biden on May 28 released his [Fiscal Year 2022 budget request](#), which includes **\$102.8 billion for education** (a 40 percent increase over FY21 enacted levels). Included in the request is: **\$20 billion increase to Title I**; **\$85 billion 10-year investment in Pell grants** for an increase of \$1,875 to the maximum grant award for year 2022–23; **\$15.5 billion for the Individuals with Disabilities Education Act** (a **\$2.6 billion increase over FY21 enacted levels**); 400 million for Teacher Quality Partnership grants, \$1.6 billion to support additional certifications for over 100,000 teachers in high-demand areas and \$30 million to recruit and train school leaders; and **\$100 billion over 10 years for broadband investment**. The work of the various Appropriations Subcommittees will continue in order to put together recommendations for the full Appropriations Committee. **The Senate has scheduled its first budget hearing on June 8.** The federal fiscal year ends on Sept. 30, 2021. ## After CSBA lawsuits, state includes a rebenching of the Proposition 98 guarantee in May Revision



As CSBA detailed recently in its [summary of the May Revision of the Governor's budget](#), the plan proposes to expand transitional kindergarten to provide a minimum of three hours of instructional time for all 4-year-olds in the state, beginning with an investment of \$900 million for the 2022–23 school year and ramping up to \$2.7 billion in 2024–25, with the goal of serving 250,000 new

TK students. The proposal includes a rebenching of the Proposition 98 guarantee to adjust for the new students.

Rebenching the Proposition 98 guarantee is an important shift in California's approach that is responsive to CSBA's legal advocacy. In 2015, CSBA and its Education Legal Alliance filed [CSBA v. Cohen](#), which challenged the state's failure to increase the minimum guarantee to account for child care spending added in Proposition 98 without rebenching the minimum guarantee calculation higher to reflect this additional education expense. This effectively lowered the amount of money education received. In 2016, the [superior court held in favor of CSBA](#), finding that the state was required to rebench the minimum guarantee. On appeal, [CSBA settled the case along with two other lawsuits against the state](#), ensuring public schools received repayment of \$686 million due to prior year underpayments. ## Legislative update: Final budget negotiations begin



The Assembly and Senate on June 1 announced a budget deal and will now begin final negotiations with Gov. Gavin Newsom. The Legislature's proposal contains good news for schools:

**Payment deferrals:** The Legislature has agreed with CSBA's advocacy that the final June apportionment deferral of \$2.7 billion should be paid before moving to fund new programs.

**Pension relief:** The proposal covers increased pension costs to local educational agencies and community college districts over a four-year period with almost \$3 billion — another key point of CSBA advocacy.

**Unemployment Insurance relief:** The proposal reduces the increase in the Unemployment Insurance rate for the School Employees Fund from a 1.23 percent increase to a 0.5 percent increase. Although this does not fully cover the increase, it goes a long way in helping to reduce the unanticipated costs.

**Universal transitional kindergarten:** Several changes were proposed, including a phased roll out over the next five years and a rebenching of Proposition 98 to meet the increased funding needs associated with a programmatic expansion of this size. CSBA will continue to advocate to guarantee the rebenching and to address additional costs such as one-time funding for school facilities and transportation.

Issues remain, however, with proposed cost-of-living adjustments and the Education Revenue Augmentation Fund (ERAF). CSBA is supportive of the Legislature's proposed 4.05 percent COLA for all categorical programs, special education and the After School Education & Safety program and is advocating to extend the Super COLA of 5.07 percent for LCFF to include special education and home-to-school transportation.

Both the Governor and Legislature failed to address the need to close a loophole that is currently exploited to exclude charter school ADA from the excess ERAF calculation, resulting in an immediate \$900 million loss, and a \$350–500 million ongoing loss in Proposition 98 funding. 
