Legislative update: School boards made an impact during Legislative Action Week



More than 370 board members and superintendents representing school districts and county offices of education from across California came together during Legislative Action Week to meet remotely with more than one hundred state legislators and their staff. CSBA offered this flagship event in a virtual format.

that allowed a record number of attendees to share their perspective as local leaders with legislators in Sacramento.

Rising to the top of the agenda for school board members were two of CSBA's key budget issues this year, increasing the base Local Control Funding Formula and school employer pension relief. With state budget negotiations in progress now, members shared their lived local experience on these issues with legislators, reiterating CSBA's requests for each:

- The state should invest heavily in the LCFF to ensure that schools can meet rising costs, remain competitive in attracting and retaining high-quality personnel and — most importantly — help improve student outcomes and provide for their mental health and wellbeing.
- The state should continue to commit non-Proposition 98 General Fund allocations to help reduce employer contribution rates for CalSTRS and CalPERS in the short- and long-term.

As the legislative session continues and budget negotiations between the Legislature and Gov. Newsom move forward, **the local perspective and advocacy school board members brought to the Capitol during Legislative Action Week will be pivotal in informing the votes of Senators and Assemblymembers. Local Educational Agency Medi-Cal Billing Option program



The Department of Health Care Services and California Department of Education are collaborating to increase the number of local educational agencies that participate in the **LEA Medi-Cal Billing Option program**, as well as to increase the reimbursement amounts for those already participating. DHCS has released the [updated onboarding handbook](#) to provide

guidance and support for participating school staff who provide services to acquire the necessary knowledge and skills to become effective participants in the program. CalSHAPE funding for public school upgrades



The California Schools Healthy Air, Plumbing, and Efficiency Program (CalSHAPE) is providing funding to upgrade



heating, air conditioning and ventilation systems in public schools. Applications for the second round of funding, which includes \$210 million in available funds, **will begin on March 28 at 10 a.m. and close on May 31 at 5 p.m.**

Grants are awarded only for projects at sites located in an underserved community as defined in Chapter 1, Section E of the guidelines. [More information »](#)

On March 17, the Biden Administration also launched the [Clean Air in Buildings Challenge](#), which calls on all building owners and operators, schools, colleges and universities, and other organizations to adopt key strategies to improve indoor air quality in their buildings and reduce the spread of COVID-19. CSBA partner [LifeWings Peak Performance LLC's](#) (LWPP) [Safer Air Initiative](#) combines aerosol studies, ventilation, engineering and medical management to offer HVAC strategies for COVID-19 mitigation.

Mathematics framework revision open for public review



The second 60-day public review of the draft [mathematics framework](#) began on March 14. The current draft reflects input from parents, educators, students and others who commented during the first review period and during the Instructional Quality Commission's May 2021 meeting. The draft provides guidance for mathematics learning for all students at all levels of math — including calculus — and

ensures students have a wide variety of options, including pursuing science, technology, engineering and math in college and career. Also available are revised [Frequently Asked Questions](#) about the current draft. Comments will be accepted at mathframework@cde.ca.gov through May 16. All comments received will be forwarded to the State Board of Education, which is expected to take final action on the framework at its July meeting.

Rios works with school districts around the state to develop programs for students who have been left behind in their education. Stavas is a strong advocate for preventing childhood violence, and as one of the many heroes of the Boston Marathon bombings, has a strong message about responding to crisis. Public comment open for E-rate program competitive bidding rules changes



The Federal Communications Commission **extended the deadline** for filing public comments in response to the agency's proposed changes to the E-rate program's **competitive bidding rules**. Comments must now be submitted by April 27 and reply comments are due no later than May 27. The federal **E-rate program** helps schools and libraries to obtain affordable broadband.
