California assessment results show declines, hope for intervention efforts



State and national assessment data released on Oct. 24 confirms the decline in results that were expected in the first full administration of these tests since the COVID-19 pandemic sent the world into turmoil.

California Assessment of Student Performance and Progress (CAASPP), also known as **Smarter Balanced Summative Assessments, data for** the 2021–22 academic year show the impact of the pandemic on student achievement, with less than half of students (47 percent) meeting or exceeding standards for English language arts (ELA) — a 4-percentage point drop from 51 percent in 2018–19, before the public health crisis. The rate of students who met or exceeded math standards fell 7 percentage points from 40 percent to 33 percent between 2018–19 and 2021–22. However, some results hint that efforts to support academic recovery, such as expanded learning opportunities, are helping.

The release of the National Assessment of Educational Progress (NAEP) showed the largest declines in math scores on record, and a less drastic though still worrisome drop in reading scores. The rigorous standardized assessment, also known as "the nation's report card," is administered by the National Center for Education Statistics to a nationally representative sample of students in grades 4 and 8. Declines spanned the political and demographic makeup of states, making it difficult to conclude the role the length of pandemic-related campus closures played in student performance, officials said.

"California education leaders were prepared to see lower test scores due to the challenges of the COVID-19 pandemic, from remote schooling to keeping students and staff healthy when in-person instruction resumed statewide in the 2021–22 school year. While California fared better than other states in mitigating learning loss as measured by test scores, the depth of the decline is disturbing," said CSBA President Dr. Susan Heredia. "These sobering results underscore the importance of dedicating substantial resources toward learning recovery — one possible reason why California's scores dropped less than those in most other states. Nationwide results show us that declines occurred everywhere — regardless of how long students participated in virtual or in-person schooling. It is our responsibility to communicate this data and its implications transparently and use it to drive continued innovation and targeted interventions at the local level that help struggling students. Fortunately, there is plenty of research on how to do that, including through small group teaching, one-on-one tutoring, expanded learning programs and more." Legal update: CSBA-sponsored bills AB 2584 and SB 1061 provide election reforms that will benefit LEAs



On Sept. 29, Gov. Gavin Newsom signed two CSBA-sponsored election reform bills, Assembly Bill 2584 (Berman, D-Menlo Park) and Senate Bill 1061 (Laird, D-Santa Cruz). AB 2584 provides needed reforms to the recall process for local elected officials, and SB 1061 ensures that voters are aware of the cost of special elections to elect board members.

AB 2584 provides a number of reforms to modernize the recall process, including:

- Increasing the number of signatures required for a notice of intention to circulate a recall petition;
- Providing that the statement of reasons for the recall or the answer are not exempt from criminal or civil liability for false, slanderous or libelous material included in

recall petitions;

- Allowing a voter to file a writ or request for injunction of the statement of reasons or answer are false, misleading or inconsistent with the statutory recall requirements;
- Requiring the estimated cost of a recall election to be stated on the recall petition;
 and
- Allowing recall petitions to be consolidated with regular elections held within 180 days of the order for the recall election.

SB 1061 similarly requires the estimated cost of special elections to fill board vacancies to be provided in petitions to call for a special election, calculated on a perpupil basis. SB 1061 also allows special elections to fill board vacancies to be consolidated with a regular or previously scheduled special election if that election is scheduled within 180 days of the order for an election to fill the board vacancy. **Read more on the CSBA blog** »

Teams from a select cohort of four school districts in rent-burdened communities around the state met at Selma Community Housing in Los Angeles recently for the launch of a pilot CSBA workshop series designed to help convert existing school property into employee housing. The Education Workforce Housing (EWH) Workshop Series, funded by a grant from the Chan Zuckerberg Initiative, builds

upon the ground-breaking research collaboration between UCLA cityLAB, UC
Berkeley Center for Cities + Schools and CSBA into best practices and
opportunities to develop housing using land owned by LEAs. *Education Workforce Housing in California: Developing the 21st Century Campus* and its companion
handbook provide a much-needed guide to navigate the complexities involved in
affordable housing development as more LEAs refuse to wait for municipalities to take
action.

At the Los Angeles workshop, each team shared details about their projects, collaborated on the challenges ahead and walked away with materials and tools to conduct geospatial analysis on potential housing sites and begin the process of consensus-building around the vision for housing in their communities. 
