School leaders share the inside scoop on COVID-19 relief aid in latest report



CSBA has released the findings of a **wide-ranging survey of superintendents and financial staff from local educational agencies throughout the state, showcasing their priorities, challenges and recommendations for spending state and federal COVID relief funding**. *Beyond the Spreadsheets: Insights from California education leaders utilizing COVID-19 relief funding* highlights the

extraordinary efforts of school districts and county offices of education to address the variety of priorities they face in dealing with the impacts of the pandemic. The survey respondents represent LEAs that serve over 1.3 million of California's K-12 students and represent a wide geographic range of elementary, high school and unified districts as well as county offices of education.

"COVID-19 relief funding has been essential to LEA leaders as they provide students and school communities with the programs and services needed to overcome the impacts of the COVID-19 pandemic, try to regain academic ground and make new advancements," said CSBA CEO & Executive Director Vernon M. Billy. "This report builds on [CSBA's prior report on federal relief funding](#) and offers a first-hand glimpse at what decisions LEA leaders have faced and continue to grapple with as they navigate the important work of educating students." Legislative update: Bills signed on ethics training, employment and emergency teaching permits



With less than two weeks left in the signing period, Gov. Gavin Newsom has issued decisions on several key bills for schools:

- **Assembly Bill 2158** (Fong, R-Bakersfield) will ensure each member of the governing board of a school district, county board of education and charter school receives ethics training and require receipt of ethics training before Jan. 1, 2026, and at least once every two years thereafter. *CSBA position: Support. This law will create parity by adding governing board members who help lead local educational agencies to the ethics training requirements that apply to other local government boards and codify the good government practices to which many school district and county boards of education members already adhere.*
- **AB 2188** (Quirk, D-Hayward) will prohibit employers from discriminating in hiring, termination or terms and conditions of employment based on a person's off-the-job use of cannabis or a drug screening test finding the presence of nonpsychoactive cannabis metabolites in their system, beginning Jan. 1, 2024. *CSBA position: Tracking*
- **Senate Bill 1397** (Borgeas, R-Fresno) will require the Commission on Teacher Credentialing to waive the basic skills proficiency requirement for the issuance of an emergency 30-day substitute teaching permit until July 1, 2024. *CSBA position: Support if Amended. CSBA successfully advocated for amendments making the bill's provisions time-limited to allow them to be re-evaluated in the future.*

With many education bills still waiting on his desk, the Governor has until Sept. 30 to sign or veto all remaining legislation.

State Board of Education takes deep dive into

assessments and the Dashboard



Accountability and assessments were key topics of the State Board of Education's [Sept. 14–15 meeting](#), which included thorough discussion on continued use of the adjusted form blueprints for the Smarter Balanced Summative Assessments for English language arts/literacy and mathematics, and the California Assessment of Student Performance and Progress (CAASPP) and English

Language Proficiency Assessments for California (ELPAC) Student Score Reports for 2022–23.

The board also approved of the **continuation of modified reporting methods for accountability as well as non-modified methods on the California School Dashboard** in response to recent action taken by the U.S. Department of Education related to California's Dashboard Alternative School Status. Other **minor changes to the California School Dashboard were approved, and the board welcomed two new members:** Alison Yoshimoto-Towery, executive director of the UC/CSU California Collaborative for Neurodiversity and Learning and former Los Angeles Unified School District chief academic officer, and Naomi Porter, a Palos Verdes Peninsula USD high school senior. Federal update: Meals, safety and assessments



The U.S. Department of Agriculture [announced](#) on Sept. 14 that it will provide nearly \$2 billion in additional funding to food banks and school meal programs for purchasing American-grown foods. This investment includes nearly \$500 million for schools across the country to purchase food for their lunch and breakfast programs.

Meanwhile, about 50 Congressional representatives, including 18 from California, wrote a [letter](#) on Sept. 15 to **Congressional leaders urging the inclusion of funding for school meals as part of the next continuing resolution.**


Additional federal updates:

- U.S. Education Secretary Miguel Cardona sent a [letter](#) to chief state school officers on Sept. 15 regarding the passage of the **Bipartisan Safer Communities Act**, which aims to reduce the risk of gun violence in schools and communities. The legislation includes **\$1 billion in formula funding under Title IV, Part A of ESEA to state educational agencies to provide students with safer and healthier learning environments**. The letter encouraged states to prioritize funds for local educational agency applicants seeking to implement comprehensive, evidence-based strategies that meet each student's social-

emotional, physical and mental well-being needs; create positive, inclusive and supportive school environments; and increase access to place-based interventions and services, among other factors.

- Cardona also wrote a dear colleague [letter](#) on Sept. 13 regarding the importance and purpose of assessments. The letter **offers considerations around possible interpretation, use and communication of school year 2021–22 assessment data**.

Hispanic Heritage Month: 40-year-old program continues raising college-going rates




California is home to the largest Latino population in the United States, with **55 percent** of the student population identifying as Latino/Hispanic. (The terms are often used interchangeably in education, as Hispanic is the official state and federal category for this population.) **National Hispanic Heritage Month is celebrated Sept. 15 to Oct. 15** and provides a time to emphasize and appreciate the history, heritage and

contributions of the ancestors of American citizens who came from Mexico, Spain, the Caribbean, and South and Central America.

The first in a series of posts on the [CSBA blog](#) highlighting important programs improving outcomes for Latino youth details the **Puente Project — a nationally recognized program that has boosted the college-going rate of tens of thousands of educationally underrepresented students** throughout the state. Now implemented in seven middle schools, 36 high schools and 65 community colleges, **the program comprises three parts to address specific challenges faced by Latino youth:** rigorous language arts instruction, sustained academic counseling, and community
