State update: CDPH updates illness guidance; Cradle-to-Career Data System



The **California Department of Public Health released updated guidance** for schools on when students should be kept home when presenting signs of illness. The updates reflect a shift from the state of emergency to a new framework that **encourages attendance** if a student's ability to meaningfully participate isn't hindered by their symptoms.

Children in need of emergency care or those dealing with symptoms that make them unable to participate in school activities should stay home. Children whose need for care is greater than the staff can provide without compromising the health

and safety of other children should also stay home. The **guidance recommends various courses of action for other symptomatic children who do not meet these criteria based on their symptoms.** For instance, a student with a cough and common cold symptoms may attend school unless they have either a fever, difficulty with or a rapid rate of breathing, a cough severe enough that they cannot catch their breath after coughing, or a cough suspected to be associated with asthma that cannot be controlled by the medications the child has been prescribed. - On Nov. 1, Gov. Gavin Newsom announced the **state's Cradle-to-Career Data System successfully received its first data installment from contributing partners** — including the California Department of Education, several offices representing institutions for higher education, the departments of Health Care and Social Services and more — **allowing the state to integrate more than 1 billion data points that have been collected and validated at the state level.** The system's integration of data will provide the public, researchers and policymakers new insight that could improve education and quality of life for Californians. Federal update: AI Executive Order



The **U.S. Department of Education must develop a toolkit with resources, policies and guidance based on the principles outlined in the Biden-Harris Administration's 2022 [Artificial Intelligence \(AI\) Bill of Rights blueprint](#) within a year of President Biden's Oct. 30 [Executive Order on the Safe, Secure, and Trustworthy](#)**

Development and Use of Artificial Intelligence. The order features education, workforce and student privacy programs and directives to multiple federal agencies, including the Departments of Labor, State and Commerce, and the National Science Foundation. With the use of AI rapidly expanding in classrooms, the order also directs the Justice Department to coordinate with federal civil rights officials on ways to investigate discrimination perpetuated by algorithms. Computer science growth is booming, despite persistent disparities



A Nov. 2 [report](#) from the Expanding Computing Education Pathways Alliance (ECEP), Code.org and the Computer Science Teachers Association shows **2023 experienced the largest growth in the percentage of high schools offering foundational computer science since 2018, with more than 57 percent of U.S. public high schools now offering foundational computer science — up from 53 percent last year.**

However, **disparities in access persist.** For instance, only 31 percent of students who took foundational computer science are female, and small districts are two times less likely to offer computer science.

In **California, access lags the national rate, with 45 percent of students having access to a foundational computer science class** (state breakdowns are [available here](#)). The report offers **recommendations** on how local and state leaders can **expand offerings and strengthen computer science instruction.** [Read the 2023 State of Computer Science Education report »](#)
