## Legislative update: CSBA advocates on behalf of SB 765



As the Legislature reconvenes this week for the final month of the 2023 legislative year, the fate of one of CSBA's sponsored bills hangs in the balance. **Senate Bill 765 (Portantino, D-Glendale)**, which would provide some immediate relief amid the ongoing teacher shortage by allowing retired teachers to more easily return to classrooms, is likely to be heard in the Assembly Public Employees and

**Retirement (PER) Committee in the coming weeks.** The bill, which must be approved to move forward, has so far not received a hearing by the PER Committee due to

concerns that streamlining the 180-day mandatory waiting period and the salary earning cap local educational agencies must observe before hiring a recently retired teacher would negatively affect the stability of the California State Teachers' Retirement System (CalSTRS).

**CSBA shares this dedication to safeguarding the state's pension system, but the lessons learned since the passage of the California Public Employees' Pension Reform Act (PEPRA) in 2012 and the guardrails put into place in the language of SB 765 will ensure that the bill will be able to ease the pressure of the teacher shortage without endangering CalSTRS.**

**CSBA President Suasan Markarian joined State Superintendent of Public Instruction Tony Thurmond and other education leaders on Aug. 14 for a press conference launching a new statewide coalition to recruit teacher candidates.** She shared the unique challenges faced by rural districts in this area and championed **SB 765**. ## CSBA leaders meet with Assembly Speaker Robert Rivas



On Aug. 10, CSBA President Susan Markarian and CEO & Executive Director Vernon M. Billy met with the new Speaker of the Assembly, Robert Rivas (D-Hollister), to discuss the challenges and opportunities facing school board members as well as CSBA's [sponsored legislation](#), budget priorities and other hot topics affecting local educational agencies. They also discussed priority legislation moving

**through the Legislature**, including [Assembly Bill 1699](#) (McCarty, D-Sacramento) and [AB 1078](#) (Jackson, D-Riverside), and emphasized the unintended impacts that one-size-fits-all lawmaking can have on California's highly diverse school districts.

**Markarian and Speaker Rivas also discussed their shared experience as leaders coming from a rural and agricultural background and the unique challenges facing small and rural school districts.** Hailing from San Benito County, Speaker Rivas is the first assemblymember from a rural area of California to serve as Assembly Speaker since 1996. Meeting with Speaker Rivas will help to build further on the strong relationships that form the core of CSBA's advocacy work to serve California's students.

## State update: Governor spotlights California's embrace of local control, parental engagement



Gov. Gavin Newsom addressed reporters at an elementary school in the Elk Grove Unified School District on Aug. 14 to **highlight the state's**



“family agenda” centered around efforts to enrich and empower kids and parents in schools.

Gov. Newsom discussed the billions of dollars being invested by the state through multi-year funds to expand after-school and summer school learning opportunities; develop community schools; recruit and retain teachers; promote arts education; improve literacy instruction; provide high-dose tutoring, universal school meals and mental and behavioral health supports; renovate nutrition facilities; and increase college-going rates through college savings accounts, dual enrollment, additional higher education funding and more. Amid these various investments, the Governor **noted that parental engagement is a foundational aspect, citing the Local Control Funding Formula and the Local Control and Accountability Plan process, which requires extensive parental engagement.** [Read more on the CSBA blog »](#)

## Legal update: Court of Appeal issues opinion in favor of Alameda USD parcel tax



On Aug. 3, the **Court of Appeal for the First Appellate District of California issued its opinion in the case of *Traiman v. Alameda Unified School District* reversing the lower court's decision and validating the tax levied by the school district.** The case relates to Measure A, a qualified special tax voted on and approved by voters in Alameda USD in 2020.

Specifically, Measure A authorized a tax on improved parcels at “the rate of \$0.265 per building square foot not to exceed \$7,999 per parcel.” Leland Traiman **challenged the approved tax** by filing a Complaint for Invalidation in May 2020, **arguing that it was invalid because it violated Government Code section 50079, which requires school district-levied qualified special taxes to be uniformly applied to taxpayers or property within the district.**

The **Court of Appeal found that “the Measure A tax applies uniformly within the meaning of Section 50079 because every nonexempt taxpayer and every improved parcel in the District is taxed using the same formula. Neither the language in the statute, case law, legislative history, nor public policy indicates that a school district cannot base a qualified special tax on building square footage with a maximum tax per parcel.”** The court’s decision provides a detailed analysis of Section 50079’s language and legislative history, as well as public policy related to it and case law on the topic of uniformity in tax structures. **This analysis and resulting conclusions align with the arguments made in the Education Legal Alliance’s amicus brief.** [Read more on the CSBA blog »](#)
