Legislative update: Legislature passes education budget trailer bills



On Sept. 11, the Legislature passed follow-up budget legislation offering more detail for education stakeholders on the Budget Act of 2023. **Senate Bill 141, the education omnibus budget trailer bill, makes a number of statutory changes needed to implement the budget.** Most notably, it will extend the authority to allow substitute teachers to remain in a classroom for up to 60 cumulative days. This

authority, which expired July 1, 2023, will now be extended by one year until July 1, 2024.

Unlike in a typical budget year, **further edits may be needed later this fall as the state continues to face uncertain revenues. Complicating matters is the state's delayed tax filing deadline**, which was extended until Oct. 15 to provide relief for Californians affected by severe winter storms. **The extension will delay an accurate count of the state's revenues, potentially requiring a revision of the budget**, which would be included as a part of the Governor's January Budget Proposal if funds fall short of what is expected. CSBA will continue to keep members informed as the situation develops.

Federal update: 2024 United States Senate Youth Program nominations open



Nominations are open for the 2024 U.S. Senate Youth Program. **Geared for juniors or seniors interested in pursuing careers in public service, two student delegates from each state will be selected to attend a unique program in Washington, D.C., from March 2–9, 2024, and each will receive a \$10,000 college scholarship.** To apply, students must be nominated by their high school principal and

Spark student civic engagement during September High School Voter Education Weeks



Per California Education Code, **the last two weeks of September are designated as High School Voter Education Weeks**, a time for teens to learn about and prepare to engage in the democratic process.

Schools are encouraged to partner with local county elections officials “to promote civic education and participation on campus and

foster an environment that cultivates lifelong voters and active citizens,” according to the Secretary of State’s website. As high schoolers return from summer break and refocus on academics and planning for life post-graduation, the department has a **back-**

[to-school pre-registration toolkit](#) available to encourage eligible 16- and 17-year-olds to pre-register online to vote, with their registration becoming active upon turning 18, and middle and high schools can also begin preparing to participate in the [2024 California Student Mock Election](#), scheduled to take place on Oct. 8, 2024.
