## Legislative update: Legislative Analyst urges caution on increased spending after budget trailer bill release



The Department of Finance has released [trailer bill language](#) for Gov. Gavin Newsom's January budget, including the education omnibus trailer bill, providing more detail on the Governor's [proposed 2023–24 TK-12 education budget](#). The trailer bill homes in on major provisions of the Governor's proposal as budget hearings in the Legislature begin, while a [new analysis](#) from the Legislative Analyst's Office

warns that more education cuts may be necessary. Key proposals in the trailer bill include one-time funds and a block grant reduction to fully fund a cost-of-living adjustment; details on the proposed Local Control Funding Formula Equity

## Federal updates: State of the Union Address



President Joe Biden delivered his [\*\*State of the Union Address\*\*](#) on Feb. 7, announcing several priorities his Administration has surrounding education. Following California's lead, Biden cited the benefits of **providing access to preschool for 3- and 4-year-olds**, as well as **connecting students to career opportunities in high school** and providing two years of community college. Other proposals include

**promoting greater access to mental health services at schools; raising teacher salaries; replacing lead pipes** in 400,000 schools and child care centers; **cracking down on fentanyl** production, sale and trafficking; **restoring the full Child Tax Credit**, which cut child poverty in half while it was in place; **barring tech companies including social media from collecting personal data on youth online and banning targeted advertising to children**; and ensuring every community has **access to affordable, high-speed internet**. "No parent should have to drive to a McDonald's parking lot so their kid can do their homework online," Biden said, a sentiment shared in a [commentary](#) penned by CSBA CEO & Executive Director Vernon M. ### In other federal news:

- The U.S. Department of Agriculture's Food and Nutrition Service (FNS) announced a proposed rule that would phase back in stricter nutrition guidelines for school meals, including the amount of added sugar and sodium permitted in meals, as well as increasing the use of whole grain products. FNS had introduced more flexibility in meeting certain nutrition requirements under the Trump Administration, and additional flexibilities have been provided over the past three years to address school meal challenges associated with the COVID-19 pandemic. - The U.S. Department of Education's Office of Civil Rights has released a fact sheet — [\*\*Diversity & Inclusion Activities Under Title VI\*\*](#) — to help school communities, including students, families, educators and local educational agencies, better understand that diversity, equity and inclusion training and similar activities in most factual circumstances are consistent with Title VI, which prohibits discrimination based on race, color or national origin in the programs or activities of all recipients of federal financial assistance. Activities intended to further diversity, equity, accessibility and inclusion are not generally or categorically prohibited under Title VI, according to the fact sheet.

## CCEE details upcoming professional development opportunities for educators



Professional development opportunities were discussed during the California Collaborative for Educational Excellence's governing board **meeting** on Feb. 2. There are three projects led by county offices of education that were funded by the Learning Acceleration System Grant: **The California Collaborative for Learning Acceleration**, led by Santa Clara COE with a focus on math, literacy, and language

development; the **California Literacy Elevation by Accelerating Learning** (Project CLEAR) for literacy and language development, led by San Diego COE; and the **Rural Math Collaborative**, led by Lake COE. **Each lead is launching professional learning modules and hosting events between now and this fall. ## Indoor air quality awareness funding available



The California Department of Public Health announced a **new funding opportunity to educate, increase awareness, and engage schools and communities on the importance of indoor air quality**. Schools and districts are eligible to apply for the IAQ Community Education Grant, which offers funding to support schools in developing and disseminating innovative educational materials on how to improve indoor air

Ballots for this year's CSBA Delegate Assembly, in subregions that have elections, were mailed to school districts and county offices of education by Feb. 1. **Completed ballots should be returned to CSBA's West Sacramento office and must be postmarked by the U.S. Postal Service no later than Wednesday, March 15, to be valid.** All districts, county offices of education and candidates will be notified of the results by April 1.
