## Legislative update: First major Legislative deadline approaches



Key education proposals are approaching their first do-or-die moment of the 2023–24 legislative year. April 28 marks the first policy committee deadline, the date by which all “fiscal bills” (those requiring an appropriation of funds) must pass out of their assigned policy committees and move to the Appropriations Committee in order to move forward. Non-fiscal bills are granted a little more time, with a deadline of May 5.

Two CSBA-sponsored bills have already cleared this hurdle with another expected to pass this week: **Assembly Bill 417** (Bennett, D-Ventura), which **would increase**

**county boards of education's authority to appoint a student school board member**, sailed through its policy committee hearings and approval on the Assembly floor and has moved on to the Senate. **AB 483** (Muratsuchi, D-Torrance), cleared the Assembly Health Committee on March 21 and is now waiting to be considered in the Assembly Appropriations Committee. This **bill would expand access to school-based health and mental health services by increasing funding available to support student support services by improving and streamlining the Medi-Cal Local Education Agency Medi-Cal Billing Option Program** (LEA BOP). **AB 1023** (Papan, D-San Mateo), **which would authorize LEAs to use discretionary funding provided under the Arts, & Music and Instructional Materials Discretionary Block Grant for cybersecurity purposes**, is awaiting consideration by the Assembly Education Committee on April 26 and is expected to pass. 
## Experts share school safety tips at CSBA webinar



CSBA's April 18 webinar, "**Safety First: Expert tips for supporting effective school safety plans and student mental health,**" offered advice on comprehensive school safety plans, district-level strategies to keep students and staff safe, and the impact that threats have on mental health.

Tom Herman, administrator of the California Department of Education's School Health and Safety Office, explained the **fundamental components of the legally required comprehensive school safety plan.** Darshana Patel, Poway USD board president, and San Bernardino USD Police Chief Joseph Paulino shared their respective districts' safety plans as well as initiatives that have proven successful in helping to build trust and share information within their communities. Erika Felix, a professor at University of California, Santa Barbara, and a licensed clinical psychologist, **discussed the mental health implications of bullying, safety drills and more.** [Read a full recap on the CSBA blog »](#)

## Commission on Teacher Credentialing moves key

## initiatives forward



The California Commission on Teacher Credentialing [met April 19-21](#) to take action on items including **the regulatory package for the PK-3 Early Childhood Education Specialist Instruction Credential and Teaching Performance Assessment (TPA) standards for literacy instruction**, among others. **Both items were adopted**, and this meeting marked at least the second time the commission had reviewed them after sending back to staff for revisions.

Major milestones were reached in key years-long, yet whirlwind, initiatives. The adoption of the PK-3 ECE Specialist credential was the culmination of work that began in 2021 to refocus and repurpose the existing Early Childhood Specialist Credential to serve as a PK-3 credential in response to expanding universal transitional kindergarten. Discussion regarding the creation of Literacy Program Standards and Teaching Performance Expectations for literacy instruction as directed by Senate Bill 488 began in 2021; the adoption of the Teacher Performance Assessment standards marks its completion.
