## Federal update: Children's Online Privacy Protection Act regulations



The Federal Trade Commission (FTC) [proposed significant changes](#) to the Children's Online Privacy Protection Act (COPPA) regulations on Dec. 20 that include new data security requirements and formalizing a school's ability to provide verifiable consent on behalf of parents. The public will have 60 days to file comments after the [notice of proposed rulemaking](#) appears in the

Federal Register — likely sometime in January. The FTC last made changes to the COPPA Rule in 2013. [Learn more »](#)

### In other federal news:

- The **Federal Communications Commission's Wireline Competition Bureau** on **Dec. 21 approved a request** filed by the State E-Rate Coordinators' Alliance and the Schools, Health and Libraries Broadband Coalition **seeking to extend the comment and reply comment periods for the pending E-Rate WiFi Hot Spots proceeding.** The new comment deadline is Jan. 16, and the new reply comment deadline is Jan. 29.
- Action for Healthy Kids and the U.S. Department of Agriculture are currently **accepting applications for the Healthy Meals Incentive (HMI) Recognition Awards,** which spotlight innovative strategies that school districts have used to serve meals that meet the **2020–25 Dietary Guidelines for Americans.** Districts that have made significant nutritional improvements to the quality of their school meals can [learn more and apply »](#)

## State updates: Speed cameras in school zones



Under a **new pilot program, six cities** — Los Angeles, San Jose, Oakland, Glendale and Long Beach, and the City and County of San Francisco — **may use up to 33 cameras to enforce speed limits in school zones** and designated “safety corridors.” Authorized under [Assembly Bill 645](#), the pilot **aims to deter speeding, which has contributed to collisions killing or injuring children and others** near schools throughout the state.

According to the National Transportation Safety Board, **speeding accounts for nearly a third of all traffic fatalities**. In California, traffic fatalities and serious injuries increased by more than 15 percent from 2020 to 2021. Among the more than 4,000 Californians who lost their lives in traffic collisions that year, over 1,000 were pedestrians and cyclists. According to the National Highway Traffic and Safety Administration, a **pedestrian struck at 20 miles per hour has a 90 percent chance of survival**. That number drops to 20 percent if the car is traveling at 40 miles per hour.

## Millions of eligible children disenrolled from Medicaid following pandemic policy rollback



Children account for nearly 40 percent of the **10.6 million Medicaid disenrollments** reported by states as of Nov. 14, according to the [Kaiser Family Foundation](#), which tracks state Medicaid data. As of September 2023 in California, **nearly 704,000 people have been disenrolled, 21 percent (more than 151,000) of whom were children**.

School-based health centers have been recognized for increasing access to care among underserved communities and in rural areas. For many of the millions of students receiving school-based health services, schools are the first — and sometimes only —

option to receive health care. And with at least 70 percent of students who access mental health services also doing so in a school-based setting, expanding access is even more critical as demand continues to rise. A recent change in California's Medi-Cal program authorizes schools to bill Medi-Cal for services provided to all Medi-Cal eligible students, not only those with an individualized education programs.

Of the more than 2 million children disenrolled across 21 states, **about 70 percent occurred as a result of procedural reasons**, including outdated contact information or because people failed to complete renewal packets on time. Schools — which already have access to families' contact and home address information — can help students renew their coverage through reminders via letters, text messages, social media and other communications to make children and families aware of the change in public health policy that may render them ineligible due to a lack of proper paperwork. 
