Communication tips: End of ESSER funding

California School Dashboard update



While the **public release of the updated California School Dashboard will occur on Nov. 21**, local educational agencies were granted access on Nov. 13-19 to preview their information and ask questions related to the **new focus it places on supporting Long-Term English Learners (LTELs)**. LTELs, for purposes of the Dashboard, is defined as “a pupil who has not attained English language proficiency within

seven years of initial classification as an English learner.” The new LTEL indicator will have a significant impact on results. **Based on early runs of the data, the California Department of Education reports seeing a very large impact with LTEL showing up in the top three student groups for differentiated assistance.** CSBA will be sending an analysis of the public release on Nov. 21 to members.

State Board of Education finalizes LCAP template



During its [final meeting](#) of 2024, the California State Board of Education [adopted revisions to the Local Control and Accountability Plan \(LCAP\) template for the 2025–26 year](#), pushed back updates to student assessment reporting, and heard ideas from student leaders throughout the state to improve their outcomes and well-being. The board [adopted the Local Control and Accountability Plan template and instructions](#)

[revisions](#), which include reporting on all planned expenditures using Learning Recovery Emergency Block Grant funds, identification of at least one metric to monitor the impact of each identified action or service, and more.

The board [discussed proposed revisions](#) to the reporting achievement level descriptors for the Smarter Balanced Summative Assessments for English language arts/literacy and mathematics and the California Science Test that [align with the Smarter Balanced Assessment Consortium one-page brief](#), "[Smarter Balanced Assessments: What Do the Scores Mean?](#)" The revisions proposed [would not impact the comparability of student assessment results from year to year](#) as they do not change the level of rigor in the assessments, [nor do they change the cut scores for each achievement level](#), several board members noted. The board directed California Department of Education staff to gather more feedback from the field for further discussion in January. [Read more on the CSBA blog »](#)
