## Modest progress on School Dashboard continues trend of sluggish growth



The California Department of Education (CDE) unveiled [the latest edition of the California School Dashboard](#) on Nov. 21, touting “continued progress in academic achievement and graduation rates” and a “decline in chronic absenteeism.” While some growth was evident, a look at the underlying data reveals a more complicated picture of student performance — one that **demands greater scrutiny of the status quo**,

**increased investment in public schools, and wider replication of local strategies that have accelerated student achievement and well-being.**

Overall, the snapshot of student performance shows that, starting from a low baseline, most student groups are demonstrating modest improvement, but at an extremely sluggish pace that will fail to close achievement gaps or vault overall student performance to an acceptable level within this generation or the next. ## LAO releases much-anticipated state budget revenue projections for 2025–26



On Nov. 20, the state's nonpartisan Legislative Analyst's Office (LAO) released its [annual fiscal outlook](#) for the 2025–26 state budget. Slightly higher state revenues driven by continued stock market growth means the LAO's assessment offers a brighter picture than last year's dismal forecast, but storm clouds remain on the horizon due to weakness in the overall state economy, the unpredictability of

future tax revenues, and fiscal pressures that are problematic for local educational agencies.

An important tool for the Legislature, the LAO's fiscal outlook provides the Assembly and the Senate, as well as the public, an independent and critical analysis of the state budget, its revenues and what to expect as Gov. Gavin Newsom prepares the release of his January Budget Proposal. The report provides a valuable assessment of the state's financial health for the current budget year and into the near future. ## Federal update: New FAFSA form released



On Nov. 21, the U.S. Department of Education [published](#) the 2025–26 Free Application for Federal Student Aid (FAFSA) form for those seeking financial aid for college or career school. The new form incorporates feedback from students, parents and educators and withstood multiple rounds of testing following the previous year's botched rollout. A number of accompanying resources, including a [tool](#) to help applicants

determine who needs to provide contributor information and an [aid estimator](#), are also available on the [federal student aid website](#).

### In other federal news:

- The Education Department's Office of Civil Rights published the [guidance document "Avoiding the Discriminatory Use of Artificial Intelligence"](#) for use by K-12 educators to ensure the technology is used in accordance with federal civil rights laws.

- The Education Department released the guidance document "[Using Functional Behavioral Assessments to Create Supportive Learning Environments](#)" that provides information on the topic as well as behavioral plans to address student behavior with a focus on how such evidence based-practices can lessen reliance on exclusionary discipline.

## IQC makes selections for new math instructional materials reviewers

At its last [meeting](#) of 2024, the Instructional Quality Commission (IQC) on Nov. 20 considered applications for instructional materials reviewers (IMRs) and content review experts (CREs) for the 2025 Mathematics



Instructional Materials Adoption and voted on the list of individuals it is recommending to the State Board of Education.

Recruitment efforts took place between April and September 2024 and California Department of Education staff presented 165 IMR and seven CRE applicants for consideration by the IQC — all of whom were approved. [Read a full meeting recap »](#)
