CSBA's look at 2025



In the midst of a busy holiday season, **glancing ahead to 2025 can seem daunting, but it's necessary to properly support students, staff and community.** January 2025 will be filled with significant developments for California public schools as well as related CSBA events, trainings and resources to help members address forthcoming issues. Expect CSBA to protect K-12 funding through **budget advocacy focusing on any additional funding in Gov. Gavin Newsom's January Budget Proposal going to the Local Control Funding Formula base, no new programs or mandates, protecting**

Proposition 98 and addressing the fiscal challenges stemming from Assembly Bill 218 litigation

among other priorities. CSBA will also be tracking the State Board of Education's [proposed changes to Student Score Report descriptors](#) closely.

Webinars featured in the first quarter of 2025 include **experts speaking about high-quality math professional development in line with the new Math Framework on Jan. 22**, a **December 2024 Update Packet review on Jan. 28**, and the second in a series sponsored by CSBA's AI Taskforce on **Jan. 29**, which will provide a roadmap for crafting AI policies that align with organizational goals while safeguarding equity and transparency.

State update: Telehealth guidance for districts



The California Department of Education has released Telehealth Guidance for School Districts, developed in response to Assembly Bill 2315 (2018) and AB 167 (2021). This **resource provides practical guidance for implementing telehealth services, a vital tool for expanding access to mental health support in schools.**

Developed with input from students, educators and mental health professionals, the guidance

emphasizes ethical considerations and best practices, ensuring that student voices play a central role in care decisions. [Download the guidance »](#)

- Two high school students will represent California in the 63rd annual United States Senate Youth Program. Sarah Gao of San Diego, a senior at Canyon Crest Academy in the San Dieguito Union High School District, and Bode Gower of Hopland, a senior at Ukiah High School in the Ukiah Unified School District, were selected for their exceptional leadership skills, noteworthy commitments to their schools and communities, and academic and extracurricular achievements as California's delegates in this highly competitive program.

Federal update: Revised guidance on school resource officers



The U.S. Department of Justice released a



revised guidance document on school resource officer (SRO) programs. The guidance outlines principles for implementing effective and equitable SRO programs and considers community input and local decision-making, clear role definition and specialized training requirements. [Read the guidance »](#)

National Career Clusters Framework updated



First established in 2002, the National Career Clusters Framework **serves as a guide for schools and industry partners for career technical education (CTE) programs.** Supported by Advance CTE, the framework provides a shared structure and language for CTE program design across the United States. In fall 2024, a **new framework was released**, “designed to serve as a bridge between education and work

and a central building block for consistently designed and high-quality CTE programs. The framework was modernized to reflect the interdisciplinary nature of work, aiming to remove silos within and across career clusters, update language and groupings to better bridge industry's organization of work with education and to include modern sectors, skills and approaches to the modern world of work, while providing flexibility for future needs.
