CSBA seeks to address persistent problems encountered by local charter school authorizers



Recent developments at the state and local levels have highlighted a few troubling deficiencies in current law related to the charter school authorization process. These issues exacerbate the difficulties that both school districts and county boards of education experience in carrying out the careful steps required to fairly evaluate petitions to establish new charter schools. In response, **CSBA, along with Napa Valley Unified School**

District and Vallejo City USD, have co-sponsored Senate Bill 1380 (Dodd, D-Napa) to address the deficiencies and fix a critical loophole that persisted after recent reforms to the Charter Schools Act in 2019.

Among other things, SB 1380 would explicitly authorize a county board of education to make a finding to deny a countywide petition if a substantially similar petition has previously been denied by the governing board of a school district in which the charter school proposes to operate, locate or place its school facilities. The bill would also revise and expand the conditions under which a school district may find it is not in a position to absorb the fiscal impact of the proposed charter school. CCEE meeting covers Statewide System of Support Resource Hub, other tools



During the California Collaborative for Educational Excellence's first [board meeting](#) of the year on Feb. 29, staff presented the [Statewide System of Support Resource Hub](#), which provides information on state-funded initiatives meant to boost student outcomes and support educators, and other tools available to local educational agencies. A product of the CCEE's Transformative Systems for

Equitable Educational Outcomes Center (TSEE), the hub includes more than 130 statewide projects, grants and initiatives, and houses related webinars, toolkits, learning modules, reference guides, self-assessment frameworks and more. Users can search by initiative, student group, state performance indicators, resource type and additional criteria to find materials that meet their needs. The hub will continue to be updated.

The Statewide System of Support, which CCEE works to grow and strengthen, is intended to connect LEAs to a network of lead agencies (typically located within select county offices of education) that share expertise, program knowledge and resources with educators so they can identify solutions to local issues. **Other TSEE tools discussed** were the recently released [Levers for System Change: LEA Self-Assessment](#) website to evaluate an LEA's infrastructure and the [Statewide System of Support Directory](#) that features contact information for all state-funded education initiatives. Federal update: New guidance on Title I preschool services



The U.S. Department of Education released [new guidance](#) on the use of Elementary and Secondary Education Act (ESEA) Title I, Part A funds for preschool programs to help local educational agencies and states expand access to high-quality preschool opportunities. The guidance includes ways LEAs can partner with [community organizations](#) and [Head Start programs](#) to extend programs for

children most at risk of not meeting academic standards and [addresses the importance and requirements for coordination with other federal programs, especially for students with disabilities](#). It also [clarifies how LEAs can use funds to provide professional development to teachers and paraprofessionals](#), including using funds to encourage paraprofessionals to transition to teachers. The new guidance [was released with a Dear Colleague letter](#) on Feb. 26 from the Department of Education and the U.S. Department of Health and Human Services [emphasizing utilizing a mixed-delivery approach when providing preschool services](#). Other federal news:

- On Feb. 29, Congress passed [House Resolution 7463](#) to extend the deadline to pass the 12 Appropriations bills that make up the fiscal year 2024 Federal Budget. The deadline for passing the bill containing the [education budget has been extended to March 22](#). The U.S. Department of Education's largest K-12 program — Title I-A under the Elementary and Secondary Education Act — has reportedly been a significant point of contention among lawmakers.

State update: ESSER and GEER Annual Reports

[Elementary and Secondary School Emergency Relief \(ESSER\) Fund and Governor's Emergency Education Relief \(GEER\) Fund Year 4 Annual Reporting is open March 6–April 5](#). These reports are applicable to activities that



occurred between July 1, 2022, and June 30, 2023. The California Department of Education will be hosting an [Annual Reporting Walk-through and Technical Assistance webinar](#) on March 7 from 10–11:30 a.m. to review the ESSER and GEER Funds Annual Reporting and support local educational agencies so they can effectively and efficiently complete the reporting requirements developed by the U.S.

- State Superintendent of Public Instruction Tony Thurmond on Feb. 29 [announced](#) that **293 middle schools and high schools had been selected for the 2024 California Distinguished Schools Program**, which **recognizes two categories of exceptional schools: those closing the achievement gap and those demonstrating exceptional student performance**. The California Department of Education uses multiple measures to identify eligible schools based on their performance on the state indicators as specified on the California School Dashboard.
