A brief recap of the 2024 Coast2Coast Federal Advocacy Trip



The **2024 ACSA-CSBA Coast2Coast Federal Advocacy Trip** to Washington, D.C. was a resounding success thanks to the dedication of our members — around 260 of whom traveled about 2,800 miles to advocate in the halls of Congress on behalf of California students. Trustees and superintendents met with Senators Laphonza Butler and Alex Padilla, Speaker Emerita Nancy Pelosi, Representatives Zoe

Lofgren, Pete Aguilar and many more as they explained the needs and challenges schools face related to increasing special education funding; teacher recruitment,

retention and retirement efforts; reauthorizing the Secure Rural Schools Act; maintaining and expanding broadband access; and protecting student data and establishing cybersecurity resources.

General sessions were led by *Education Week* Assistant Editor Alyson Klein on **artificial intelligence (AI) in education**; White House Domestic Policy Advisor Neera Tanden and U.S. Deputy Education Secretary and former San Diego Unified School District Superintendent Cindy Marten on **federal education policy updates from the Biden Administration**; U.S. Department of Agriculture Acting Under Secretary Kumar Chandran on **school meals**; as well as Lake Research Partners Founder Celinda Lake and K12Counsel, LLC Founder Francisco M. State update: California extends priority deadline for financial aid



Urgency legislation signed by Gov. Gavin Newsom has **extended California's priority deadline for financial aid to May 2, 2024**. Local educational agencies are urged to help ensure that all graduating students complete a **Free Application for Federal Student Aid (FAFSA)** or **California Dream Act Application (CADAA)** before this deadline. Despite federal efforts to address technical issues students face

when trying to complete the FAFSA, many students — particularly those from mixed-status families where students who are U.S. citizens or FAFSA-eligible non-U.S. citizens have one or more parents without a Social Security number — are facing a difficult identity-verification procedure and prolonged processing times that jeopardizes their

ability to apply for and receive financial aid that they are entitled to, which can derail their journey to higher education.

In response, the University of California, California State University, California Community Colleges, Newsom's Administration and the Legislature, and the California Student Aid Commission **announced** that **students from mixed-status families who have been unable to complete a FAFSA will be able to complete the CADAA**. This will allow more students who are applying for financial aid for the first time to complete a financial aid application before the May 2 state priority deadline for financial aid. In other state news:

- On April 10, Gov. Gavin Newsom announced that the California Department of Health Care Services had awarding over \$51 million in Prop 64 funding to 75 community-based and tribal organizations to further support youth mental health and expand the state's substance abuse prevention programs. The Elevate Youth Campaign (EYC) provides three-year grants to youth-focused community-based and tribal organizations that implement evidence-based youth development, peer support and mentoring programs that help children heal and recover from trauma, cope with adversity and thrive; empower youth to get involved in their communities; and prioritize harm reduction and public health solutions that address and prevent substance use disorder. Federal update: New council launched to strengthen cybersecurity in schools



On March 28, the U.S. Department of Education and the Cybersecurity and Infrastructure Security Agency (CISA) **launched** the Government Coordinating Council (GCC) for the Education Facilities Subsector, a pivotal step forward in the national effort to enhance K-12 cybersecurity. “The importance of protecting our schools, students and educators from cyber threats cannot be overstated,” said

CISA Director Jen Easterly. “[The GCC] will have a vital role in helping to guide efforts to ensure a safer and more resilient learning environment for our classrooms across the nation.”

State and federal education officials have released resources to support **High School Voter Education Weeks**, happening April 15-26. The goal of the initiative is to **create civic awareness**



in future voters and inspire eligible 16- and 17-year-olds to preregister to vote so they are automatically able to participate in elections when they turn 18. Registration for the 2024


What's Your Why? with Elk Grove USD board member Sean Yang
