Legislative update: CSBA pursues sponsored bill package



The 2024 legislative session is in full swing as policy committees in both the Senate and the Assembly work their way through the thousands of new bills introduced since January. **Among the measures under consideration is a package of CSBA-sponsored bills that together would reduce administrative workloads associated with the substantial number of reports required of local educational agencies, ensure**

that the state provides much-needed support to small school districts in the acquisition of state bond funds, and help improve and clarify the school district and county office of education charter authorizing processes.

Senate Bill 1315 (Archuleta, D-Pico Rivera) would require the California Department of Education (CDE) to produce a report on the number of state and federal reports required of LEAs in order to assess the number, type and scope of reports and identify where information could be condensed and where some reports could be eliminated — helping LEAs free up more time and resources to provide for the needs of California's students. **Assembly Bill 2831** (Hoover, R-Folsom) proposes to establish an Office of Small School District Facilities and Construction within the CDE that would **help provide small school districts with the critical support and technical assistance they need to secure statewide facilities bond funding.** **SB 1380** (Dodd, D-Napa) **would close a legal loophole that allows the district and countywide benefit charter authorizing processes to be used interchangeably**, protects the integrity of the countywide charter authorization process, and better aligns the countywide authorization process with the review of the fiscal and community impacts that already exist in the district authorization process. 

Sign up for state-required ethics training




CSBA's Ethics Assembly Bill 2158 training, developed in response to new legislation, will give a comprehensive overview of the conflict-of-interest laws applicable to school board members, including hypothetical situations for deeper learning and additional resources. A certificate of completion will be awarded upon successful completion of this training. **AB 2158 amended the Government Code to require**

local agency officials to complete ethics trainings every two years during their term. Unlike other local agency officials, board members are subject to the ethics training requirement whether or not the member receives any type of compensation, salary,

State update: New rule for epinephrine in schools



The California Department of Public Health (CDPH) in partnership with the California Department of Education has issued a statewide standing order to help reduce morbidity and mortality associated with anaphylaxis by facilitating the distribution and administration of epinephrine in California schools. **This standing order authorizes a California school district, county office of education or charter school to**

obtain epinephrine auto injectors for elementary schools, junior high schools, middle schools and high schools. [Learn more, including how to access an LEA application to request a standing order for epinephrine »](#)

Federal update: California 2024 Green Ribbon schools awarded



The **2024 U.S. Department of Education Green Ribbon Schools, District Sustainability Awardees, and Postsecondary Sustainability Awardees** were announced April 26. Across the country, 41 schools, 10 districts, three postsecondary institutions and one early learning center are being honored for their innovative efforts to reduce environmental impact and utility costs, improve

health and wellness and offer effective sustainability education. **California's public school honorees are Cabrillo Unified School District in San Mateo County, Claremont USD in Los Angeles County, Rio School District in Ventura County and Trabuco Elementary School of Saddleback Valley USD in Orange County.** In addition, George Garcia of the California Department of Education was recognized with the Director's Award.

In other federal news:

- Applications are open through May 13 for the National Professional Development discretionary grant program focusing on improving instruction for English learners through pre-service and in-service professional development activities, including by providing grants for effective pre-service professional development programs that will increase the number and diversity of fully licensed or certified bilingual or multilingual teachers. Grants are awarded for this program to public and private nonprofit institutions of higher education and public and

private entities with experience and capacity, in consortia with state and local educational agencies. Further information is available [here](#).

- **Applications are open through May 13 for the Magnet Schools Assistance Program (MSAP), which provides funding to create or revise magnet schools that are under required or voluntary desegregation plans.** The competition has four competitive preference priorities, including priorities that “address an LEA’s need for MSAP funding, the evidence base undergirding the LEA’s program design for new or significantly revitalized magnet schools, the means of student selection for admission including use of lotteries and other non-academic means, and attention to socioeconomic factors in promoting diversity.” Further information is available [here](#).
