Legislative update: CSBA-sponsored bills move forward



The Legislature is nearing the end of the two-year 2023–24 legislative session as both the Senate and the Assembly work their way through the hundreds of remaining bills. Among those moving forward is a package of **CSBA-sponsored legislative measures that together will reduce administrative workloads associated with the substantial number of reports required of local educational agencies (Senate Bill 1315)**, ensure

that the state provides much-needed support to small school districts in the acquisition of state bond funds (**Assembly Bill 2831**), and help improve the delivery

California's high cost of housing prohibits many teachers and non-credentialed staff from living in the areas where they work. The [education workforce housing \(EWH\) report](#) found that housing costs in California are outpacing education salaries by wide margins. In response, many local educational agencies are taking steps to build housing developments for teachers and other staff.

LEAs interested in pursuing education housing are invited to apply for CSBA's upcoming **Education Housing 101 Workshop Series**, which provides the tools and knowledge to create a roadmap to affordable and inclusive housing options for staff. Cohort participants will learn from experts and practitioners including architects and researchers on all EWH planning topics. Federal update: U.S. Surgeon General declares firearm violence a public health crisis





For the first time in the nation's history, U.S. Surgeon General Dr. Vivek Murthy issued an **advisory** declaring firearm violence a public health crisis and outlining the urgent threat firearm violence poses to the health and well-being of Americans. The advisory **lays out the approach the country can take to address**

firearm violence as a public health crisis, including implementing community violence prevention programs and firearm risk reduction strategies, improving access to mental health care for those exposed to or at risk for firearm violence, and expanding research funding to inform and evaluate prevention strategies.

Firearms were the leading cause of death for children and adolescents from 1 to 19 years of age in the U.S. from 2002–22, the last year in which this data is currently available, according to the advisory. And **even those who do not experience direct bodily harm often struggle with mental health consequences related to firearm violence exposure**, including community members, children, adolescents and families. On July 2, State Superintendent of Public Instruction Tony Thurmond named two students as California's delegates to the 61st annual National Youth Science Camp (NYSCamp): Arnav Mahendra, a junior at Mira



Loma High School in the San Juan Unified School District (Sacramento County), **and Natalie Brahan**, a junior at Irvington High School in Fremont USD (Alameda County). The **NYSCamp** is an annual event hosted by the National Youth Science Academy to bring together top students from nine Western Hemisphere countries to attend lectures and participate in outdoor activities centered on science, technology, engineering, arts and mathematics (STEAM) disciplines.
