### Legislative update: Legislature adjourns the two-year 2023–24 legislative session this weekend



Considered the busiest time of the year, **legislators will be working non-stop through Aug. 31 when the 2023–24 legislative session comes to an end.** Historically, the last day of session goes right until the clock runs out and bills will be taken up until the final minutes. Some legislation, including committee and budget bills and urgency measures, do not have to adhere to the midnight deadline. However, most legislation must be dispensed with before Sept. 1, otherwise the bill will officially be dead and may

not be reconsidered or resurrected.

**Two CSBA-sponsored measures will be among those considered in these final days of the session:**

- **Senate Bill 1244** (Newman, D-Fullerton) would create a process for school districts to initiate dual enrollment programs with a neighboring community college district when an agreement cannot be reached with a home community college district. CSBA is co-sponsoring this bill with the California High School District Coalition.
- **SB 1315** (Archuleta, D-Pico Rivera) would require the California Department of Education to report to the State Superintendent of Public Instruction, Governor and the Legislature the total number of reports that local educational agencies are required to submit and recommendations for which reports could be consolidated, eliminated or truncated. CSBA is co-sponsoring this bill with the California Association of School Business Officials.

CSBA's Governmental Relations team will update members on the fate of these bills and other education-related legislation following the close of session.

## Legal update: Supreme Court issues Title IX decision



The U.S. Department of Education (ED) recently issued revised regulations regarding **Title IX**, a federal civil rights law prohibiting sex and gender discrimination in schools and colleges. The new regulations modify, and in some ways relax, the investigation of sexual harassment (now called “sex-based harassment”) and provide protections for pregnant students. Additionally, the regulations emphasize that Title IX’s

antidiscrimination protections extend to transgender students.

**Many lawsuits have been filed challenging the new regulations’ transgender protections.** For example, following a successful lawsuit in Kansas, implementation of the new regulations has been barred in certain California schools. In another lawsuit, a different group of 10 states (not including California) obtained a preliminary injunction barring implementation of the entirety of the new Title IX regulations within those states, rather than just certain challenged provisions. **In response, the ED filed an emergency petition with the U.S. Supreme Court asking the Court to overrule these injunctions to the extent they did not concern transgender protections so that the regulations’ other, unrelated provisions could go into effect.**

**On Aug. 16 the Court denied the ED’s petition. As a result, the new Title IX regulations remain entirely blocked in the 10 states that brought the lawsuit.** However, local educational agencies should be aware that the Court’s opinion does **not apply to California**, and therefore has no effect on whether California LEAs are covered by the new regulations. LEAs with questions about whether the new Title IX regulations apply to them should contact CSBA’s Legal Services team or their legal counsel.

## SBE seeking applicants for advisory positions, IQC student board member


