## Legislative update: CSBA member advocacy makes the difference



In a clear demonstration of how **CSBA advocacy influences important legislative matters**, Gov. Gavin Newsom took action on two CSBA priority bills on Sept. 22 by vetoing **Assembly Bill 2088** (McCarty, D-Sacramento) and signing into law CSBA co-sponsored legislation **Senate Bill 1315** (Archuleta, D-Pico Rivera). CSBA advocacy was critical in the Governor's veto of AB 1699, a similar bill from last year, and again played a crucial role in helping to assure its veto this year. AB 2088 would have forced school districts and county offices of education to hire existing classified staff for open positions without considering if they are well qualified for the position or their past job performance and would have fundamentally struck at the heart of local control.

In another win for CSBA's advocacy, **the Governor signed SB 1315, which is a product of direct membership input.** Co-sponsored with the California Association of School Business Officials (CASBO), it will require the California Department of Education to document and report to the Legislature the number of state and federally mandated reports districts and COEs must submit. **The goal is to identify where information could be consolidated, and which reports could be eliminated — helping schools free more time and resources to provide for the needs of California's students.**

## Federal update: Congress must take action by Oct. 1 to avoid government shutdown



On Oct. 1, the new federal fiscal year begins — and Congress has not yet approved a federal budget for FY 2025–26. **Without passage of a budget or a continuing resolution (CR), the federal government will face a shutdown beginning Oct 1.** The House of Representatives had proposed a six-month CR until March 28, 2025, that also included provisions of the SAVE Act ([HR 8281](#)), which would require individuals to provide documentary proof of U.S. citizenship in order to register to vote in federal elections. The CR was taken up on the House Floor last week and failed on a vote of 202-222.

On Sept. 22, House leadership introduced an alternate CR that would extend federal funding to Dec. 20, 2024. This would be a “clean” CR with a couple of additions, including funding for the Secret Service to provide increased protections to presidential candidates and language to allow some agencies broader access to their funding in order to address current shortfalls. **The House is scheduled to vote on the measure on Sept. 25 with the Senate vote to follow either Sept. 26 or 27. Congress only has five days**

remaining in which to act before the new fiscal year begins. Upon passage of the CR, Congress is expected to adjourn for the election period.
