Legislative update: Developments in legislation to address financial impacts of childhood sexual assault claims



This year, **two bills were introduced to help address the impacts of Assembly Bill 218 (2019)**, which made two significant changes to the statute of limitations for childhood sexual assault claims ([learn more](#)). Since then, many school districts and county offices of education have experienced a sharp rise in the number of claims, resulting in substantial financial settlements impacting their ability to provide compensation and resolution for victims while striving to meet the needs

of their students.

Two legislative measures have been introduced this year — Senate Bill 577 (Laird, D-Santa Cruz) and CSBA-supported SB 832 (Allen, D-Santa Monica). Both propose to help address the impacts of AB 218 claims, but **only SB 577 will be heard by the Senate Judiciary Committee. With SB 832 not being heard by committee, effectively killing the bill, some of its elements are expected to be amended into SB 577**. Although helpful, the amendments to SB 577 do not address the core impacts of AB 218 claims. As a result, CSBA has taken an **Oppose Unless Amended position on the bill**. Federal update: 2026 National Assessment of Educational Progress



The U.S. Department of Education [announced](#) on April 17 that the 2026 National Assessment of Educational Progress (NAEP) in reading and math are on track for administration between **Jan. 26 and March 20, 2026**. In addition to assessing math and reading in fourth and eighth grades, [a letter sent to states](#) noted that **U.S. history and civics will be administered for eighth-graders**.

The National Center for Education Statistics (NCES), which oversees the NAEP — also known

as the Nation's Report Card — saw nearly all of its 130 staffers fired in March, raising questions about how it can continue its work to measure the efficacy of the country's school districts. According to the April 17 letter, "mathematics and reading results will be reported for the nation, states, and districts participating in the Trial Urban District Assessment (TUDA). These results are expected to be released in early 2027, following the completion of quality assurance research designed to ensure the comparability and validity of the 2026 assessment results as NAEP continues to modernize its assessment delivery systems." While national results for civics and U.S. history are expected to be released later in 2027, district and state-level data for those assessments will not be released.
