# Legal update: CSBA's ELA scores a victory in defending local control of charter school authorization



In the first litigation regarding Assembly Bill 1505, a sweeping charter school reform bill, CSBA's Education Legal Alliance (ELA) secured a victory from the Court of Appeal in Napa Valley USD and CSBA's ELA v. State Board of Education. In an opinion issued March 14, the Third District Court of Appeal upheld the Superior Court decision in the ELA's favor, finding that the State Board of

Education erred when it found that the Napa Valley Unified School District (NVUSD) and the NVUSD Board of Education abused their discretion when they

denied the Mayacamas Charter School petition. This is a substantial win for charter authorizers in California. Read the details of the case on the CSBA blog »

## Trustees make their voices heard at Legislative Action Week



More than 300 board members and superintendents from across California came together last week to meet with the state senators, assemblymembers and staff that represent their local educational agency. Over a three-day period, CSBA members "held court" with the State Legislature, hosting over 110 meetings. CSBA members spoke on pressing state budget priorities

and legislation that will have great impact on LEA operations. Attendees called on the Legislature to:

- Protect Prop 98 by rejecting Gov. Gavin Newsom's effort to manipulate the Prop 98 Funding Guarantee by withholding \$1.6 billion in public education funding.
- Fully fund the estimated 2.43 percent cost-of-living adjustment and ensure that the Student Support & Professional Development Discretionary Block Grant is fully discretionary.
- Protect school district and county office of education solvency by providing related solutions for the impacts of Assembly Bill 218.

LEA leaders also advocated for **four CSBA-sponsored legislative measures** and against another, urging the Legislature to:

- Support CSBA's education workforce housing package AB 1021
   (Wicks/Muratsuchi) to expand existing incentives and efficiencies to rural and small school districts and county offices of education, and AB 1381
   (Muratsuchi) to help provide much-needed predevelopment funds for workforce housing projects.
- Support AB 1111 (Soria) to help push out the mandatory electric school bus purchase mandate by 10 years from 2035 to 2045.
- Support AB 1224 (Valencia) to expand the amount of time a substitute teacher can serve in a classroom from 30 to 60 days.
- Oppose Senate Bill 494 (Cortese), a re-introduction of SB 433 from 2023, which CSBA opposed and helped to successfully veto. It would fundamentally undermine school and county boards of education local control by removing their personnel authority to determine disciplinary outcomes for classified staff.

## State update: Artificial intelligence initiatives



Applications for the California Department of Education's (CDE) Artificial Intelligence (AI) in Education Workgroup are being accepted through April 11. The workgroup is being established in response to California's legislative mandate to develop guidance and model policies for the safe and effective use of AI in schools. Those selected will participate in three, full-day remote meetings to develop

recommendations and policies. Learn more »

To assess the landscape of Al in schools across the state, CDE is also conducting a survey for local educational agencies to share their policies and how they use the technology. Survey responses will help inform the workgroup.

CSBA convened its Al Taskforce: Education in the Age of Artificial Intelligence in 2023 and has since developed a suite of resources, including a roadmap facilitation guide, sample policies and local resolutions, original research and webinars, promising practices and more. #### CCEE talks direct technical assistance



Much of the California Collaborative for Educational Excellence's (CCEE) board meeting on March 13 focused on discussions around direct technical assistance (DTA) as the state has seen an increase in eligible districts.

In 2021, there were seven local educational agencies across 25 county offices of

education receiving DTA from CCEE, compared to 54 in 2024, which requires support from the entire organization to manage cases as well as contractors. according to Executive Director Matt Navo.
