### 2016-17 Budget Highlights

- Prop 98 Guarantee: up \$3.5 billion
- Prop 98 Per-Pupil Spending: \$10,643 up about \$500
- \$2.95 billion increase for LCFF95.7% of full implementation
- \$1.28 billion in new one-time funding \$214 per ADA
- College Readiness: \$200 million
- Preschool Rates: \$100 million
- $\rightarrow$  COLA = 0% (yes, zero)





#### 2016-17 Budget: New Money

- \$1.28 billion in one-time discretionary Prop 98 funding that counts against mandate claims
- \$200 million increase college going rates & prep
- \$300 million CTE Incentive Grants Program
- \$10 million for development of 4-year teacher credential programs
- > \$20 million for classified school employee teacher training program
- \$9.5 million safe drinking water grants



#### Governor's Budget: Early Ed

(abandoned but may return)

- Align & integrate with LCFF and LCAP
- Provide more funding for programs for neediest children
- Moves to an all voucher childcare program
  - (no more CDE contracts with childcare centers)
- Provide more discretion to implement programs aligned with local priorities
- Allows contracting with community-based organizations and forming of consortia



### State Budget: What's Missing

- Replacement for Prop 30 revenues
- Targeted program expansion
- Retirement contribution backfill (CalSTRS/CalPERS)
- New money for child care
- New money for teacher training
- Adequate funding

  - > SB 322 (Leno)
  - > AB 709 (Gipson)
- Unemployment insurance: AB 2197 (Garcia)
- Sick Leave: AB 2393 (Campos)



#### Accountability

- State Board of Ed adopts evaluation rubrics plan
- > Sets
  - Metrics
  - > Standards
  - Examples
  - > Criteria
- Rubrics guide spending in next year's LCAP
