Calif. newspapers join call for repealing reserve cap Law described as short-term gain causing long-term problems

CSBA's efforts to repeal the reserve cap contained in SB 858 received an added boost this month, with several newspapers also calling for the law's repeal. The reserve cap limits school districts' ability to save for the future and undermines local control of schools. In mid-April editorials, both the Riverside Press-Enterprise and Orange County Register wrote, "we join the LAO and the California School Boards Association in calling for the immediate repeal of the school reserve limits." Earlier in April, a chain of newspapers in Los Angeles, including the Los Angeles Daily News and Long Beach Press-Telegram, also advocated for repeal of the reserve cap, stating "Brown's reserve cap has to go." The San Diego Union-Tribune also took on the law following a news conference on the issue with San Diego-area school board members and the League of Women Voters in San Diego. At the end of March, the **Union-Tribune** wrote: "Limit on school reserves is an awful law." So far, more than 15 newspapers across California have editorialized in favor of repealing the reserve cap. For more resources, visit CSBA's Repeal Reserve Cap Web page.

iCount member survey available April 27 Survey begins second phase of iCount campaign

CSBA's iCount member survey will be available online beginning on Monday, April 27, and continue through May 18. The survey is the second phase of CSBA's state-of-the-art iCount data-gathering campaign, and it represents a key element of CSBA's long-term planning efforts. The survey will be available only in an online format — no paper copies will be produced. There are two different versions of the iCount survey: one is specific to board members, while the other is designed for superintendents. The iCount survey allows board members and superintendents to exercise their voice in the association by offering valuable feedback about CSBA services and about critical statewide education issues. More than 2,000 board members have already completed the iCount census, and it is crucial that CSBA members match this participation level when the survey launches. Board members and superintendents will receive separate emails containing links to the corresponding survey on April 27.



Two recent court decisions favor districts CSBA's Education Legal Alliance filed amicus briefs in both cases

Last week, two decisions were announced favoring school districts in which the Education Legal Alliance had filed amicus briefs in support of the school district. The **first case**, *California Charter Schools Association v. LAUSD*, concerned a Proposition 39 requirement that charter school students be given access to facilities that are "reasonably equivalent" to those available to other public school students. The primary issue of statewide concern in this case was which classrooms in a district would be courted for purposes of determining what would be "reasonably equivalent." **The California Supreme Court primarily sided** with the district and the ELA on this issue by holding that the calculation need only count those classrooms actually used by district students, although it could include nonteaching station rooms used by district students.

The **second case**, *Sedlock v. Baird*, centered on the use of yoga instruction as a component of Encinitas ESD's physical education curriculum. The legal issue concerned yoga as an impermissible establishment of religion in violation of the California Constitution. While the Court of Appeal acknowledged that Ashtanga yoga was religious in origin, the court found that the district had properly removed religious components from the program. While yoga may be practiced for religious reasons by some, the court concluded that this did not necessitate that yoga is always religious. Thus, **the court sided** with the district and the ELA in concluding that the yoga program created by Encinitas emphasized the physical and mental well-being of students and not religion in violation of the California Constitution. **Read more** about these court decisions on CSBA's website.
